Meeting hosted by the European Parliament, organised by the European Parliament jointly with the Parliament of the EU Presidency and co-chaired by the Presidents of the committees concerned.

#### - Joint Parliamentary Meeting (JPM)

Meeting hosted by the European Parliament, organised by the European Parliament jointly with the Parliament of the EU Presidency and co-chaired by the Presidents. These meetings deal with transversal issues involving more than one of the European Parliament's committees.
