INTRODUCTION

The rule of law, as enshrined in Article 2 of the Treaty on European Union, is one of the shared values upon which the European Union is founded. It is one of the threads that binds Member States together and is essential for the Union's cohesion and good functioning. Member States and all EU institutions have a common responsibility to uphold, defend and strengthen the rule of law in the Union¹.

In recent years, respect for the rule of law has been put to the test on several occasions and concerns have been raised about measures introduced in some EU Member States. In response to these concerns, in April 2019 the European Commission started a process of reflection on how to strengthen the rule of law in the European Union.

As part of this reflection process, the Commission outlined three pillars that could contribute to the more effective enforcement of the rule of law in the European Union:

- Better promotion: increased efforts should be geared towards better promoting a rule of law culture among the general public and knowledge of the rule of law standards and case law at national level.
- Early prevention: regular cooperation and dialogue could contribute to a deeper understanding of the rule of law situation and developments in Member States and could contribute to the early resolution of any rule of law issues.
- Tailored response: the EU needs to improve its capacity to act when a challenge to the rule of law emerges in a Member State. A diversity of rule of law challenges requires a diversity of effective responses².

This Eurobarometer survey was commissioned by the European Commission, Directorate General Justice and Consumers to inform the debate. It assesses the importance to citizens of a number of aspects of the rule of law, as well as their opinions about whether these aspects need improving in their country.

The survey first looks into **the importance and need for improvement for 17 principles of the rule of law** grouped into three thematic areas:

- **legality, legal certainty, equality before the law and separation of powers;**
- **prohibition of arbitrariness and penalties for corruption;**
- **effective judicial protection by independent courts.**

The survey also covers the importance of **media and civil society** as key players in safeguarding the rule of law.

The survey further asks respondents to assess the **importance of respect for the rule of law in other Member States and in the EU as a whole.**

Lastly, the survey asked respondents to assess **how well-informed they are about the fundamental values of the European Union.**

This survey was carried out by the Kantar network in the 28 EU Member States between the 9th and 26th of April 2019. Some 27,655 respondents from different social and demographic groups were interviewed face-to-face at home in their mother tongue.

The methodology used is that of the Standard Eurobarometer surveys carried out by the Directorate-General for Communication (“Media monitoring and Eurobarometer” Unit)³. It is the same for all countries and territories covered in the survey. A technical note on the manner in which interviews were conducted is appended as an annex to this report. Also included are the interview methods and margins of error⁴.

17 MAIN PRINCIPLES OF THE RULE OF LAW EXAMINED IN THIS SURVEY

Legality, legal certainty, equality before the law and separation of powers:

This aspect of rule of law is about how laws are made, and whether they are clear, stable and apply in the same way to everyone. It also covers how state powers, such as governments, parliaments, and judicial systems, cooperate and control each other to ensure that decisions are taken in the public interest. There are five principles that fall under legality, legal certainty, equality before the law and separation of powers.

1	Equality before the law: the same laws and rules apply equally to every person, including all public authorities, irrespective of their personal circumstances, social status, wealth, political connections or origin.
2	Clarity and stability of the law: the laws applying to your everyday life, work or business are clear, stable and predictable. You understand the consequences of your actions.
3	Ease in following how parliament adopts laws: it is easy to follow how and why parliament adopts laws. Debates are public and the opposition can contribute.
4	Lawmakers act in the public interest: those who make and apply laws do so exclusively in the public interest.
5	Independent controls on laws: there are independent controls to ensure that laws can be challenged and tested.

Prohibition of arbitrariness and penalties for corruption:

This is about how public authorities and politicians apply the law, and whether arbitrary decisions are prevented and corruption is punished. Six principles fall under prohibition of arbitrariness and penalties for corruption.

6	Clarity of public authorities' decisions: public authorities provide clear reasons for their decisions, for example on taxes pension, public contracts, education or healthcare.
7	Independent review of public authorities' decisions: the decisions by public authorities for example on taxes pension, public contracts, education or healthcare can be reviewed by an independent court.
8	Unbiased decisions of public authorities: public authorities take decisions for example on taxes, pensions, public contracts, education or healthcare, without favouritism or discrimination.
9	Making decisions in the public interest: public officials and politicians do not use their positions to obtain benefits for themselves or their family members but take decisions in the public interest.
10	Acting on corruption: corruption involving public officials and politicians is properly investigated and those responsible are brought to justice.
11	Codes of ethics for politicians: public officials and politicians making and applying laws should follow clear codes of ethics to avoid conflicts of interest.

Effective judicial protection by independent courts:

This is about the independence, quality and efficiency of the judicial system, and respect for court decisions. Six principles fall within this chapter.

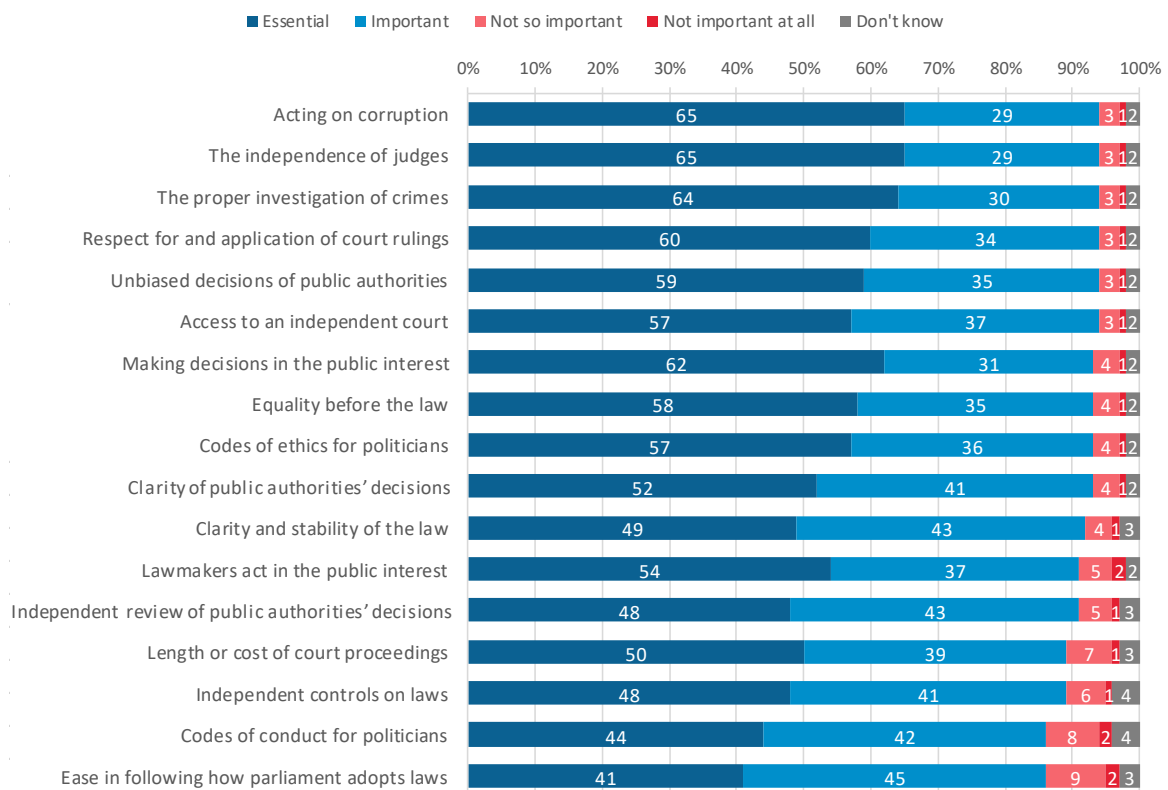
12	Access to an independent court: if individuals' rights are not respected, they can have them upheld by an independent court.
13	Length or cost of court proceedings: court proceedings are not excessively long or costly.
14	The independence of judges: judges are independent and are not under the influence of politicians or economic interests.
15	The proper investigation of crimes: the police and prosecution service investigate crimes properly, including those committed by politicians or influential persons, and they are not under the influence of politicians or economic interests.
16	Respect for and application of court rulings: public authorities and politicians respect and apply court rulings.
17	Codes of conduct for politicians: there are codes of conduct imposing limits on politicians criticising courts and judges.

KEY FINDINGS

For all principles of the rule of law covered in this study, as well as for the role of civil society and media, large majorities think they are essential or important. Significant majorities also consider that respect of these aspects needs improvement in their country. For all principles, only a very minor share of respondents believe they are not important at all or do not see any need for improvement. A large majority of respondents considers respect for the rule of law in other Member States and in the EU as a whole equally essential or important. Lastly, the majority does not feel sufficiently informed about the EU’s fundamental values.

- For each of the 17 main principles of the rule of law, a vast majority of respondents (above 85% in each case) thinks they are essential or important.** The share of respondents who consider a given principle as essential or important ranges from 86%⁵ to 94%⁶.

(% EU)



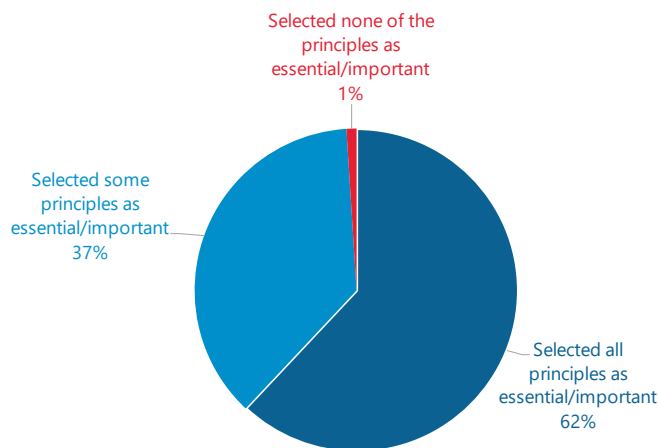

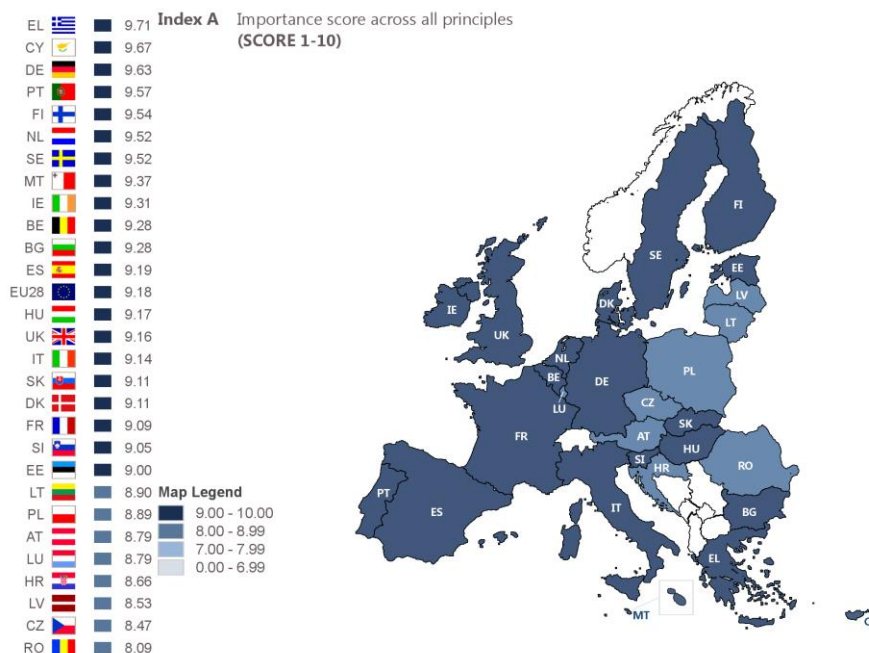
2. **More than six in ten (62%) respondents consider all 17 core principles of the rule of law as essential or important.** A further 37% highlighted some of these principles as being essential or important. Only 1% of respondents do not consider any of the principles essential or important.

3. **Taken together, the 17 main principles of the rule of law have a high perceived importance score of 9.18 out of 10.⁷** The scores are persistently high in all countries, ranging between 8.09 and 9.71 between countries.

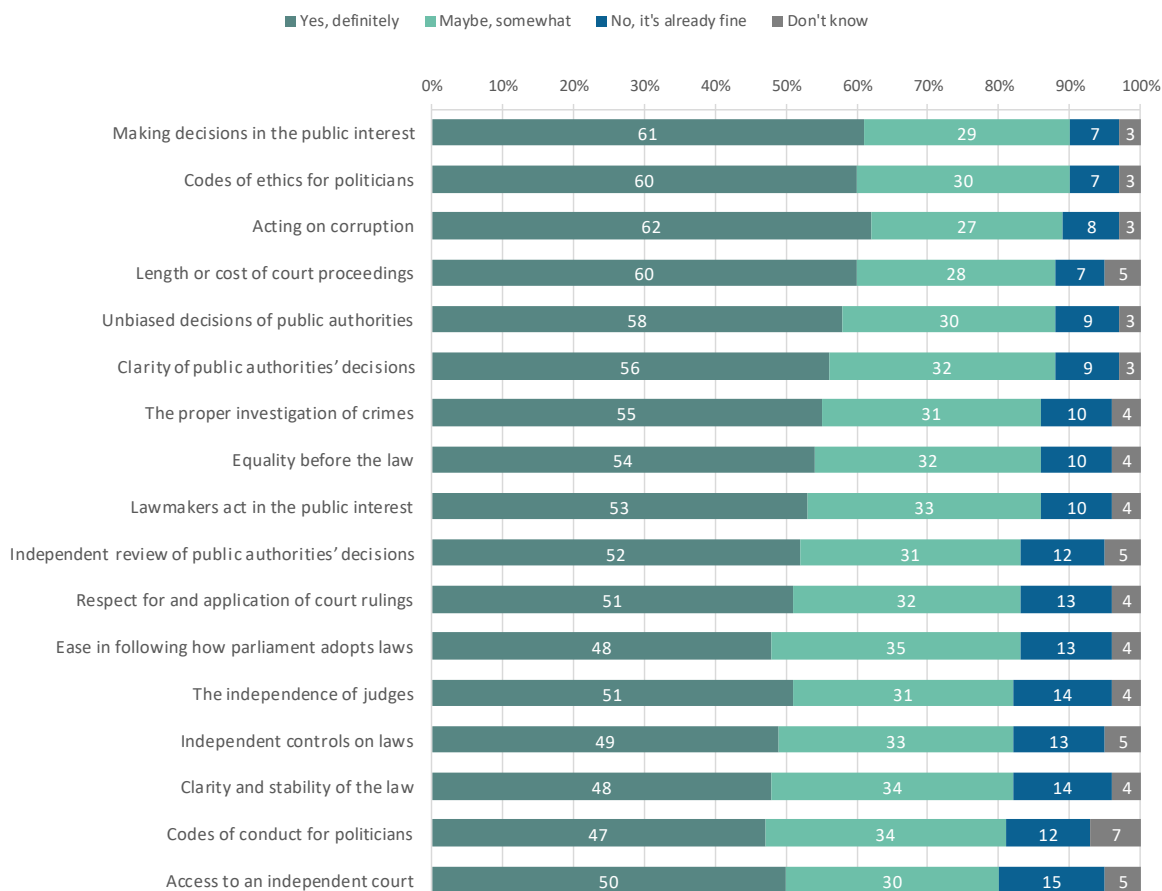

⁷ This score is calculated by assigning a score from 1 to 10 to each of the principles based on the share of respondents who stated a given principle is essential or important for them personally. The share of respondents who consider a given principle as important is divided by 10 giving a score between 1 and 10. These scores are subsequently averaged. This means that the score reflects the level of perceived importance across the 17 main principles. Given it is not possible to make an average of percentages, the score cannot be understood as the share of respondents who consider rule of law principles as important.

4. **For each of the 17 principles of the rule of law, a large majority of respondents (over 80 %) thinks that the situation in their country with regard to the respect of these principles needs at least some improvement.** For thirteen of these principles, more than half of respondents said that there is a definite need for improvement in the situation in their countries in their regard.

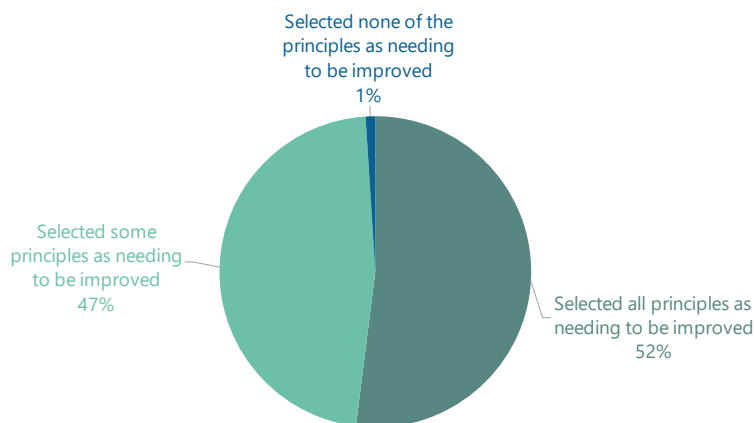
Q Please tell me whether the following points need to be improved in (OUR COUNTRY)? (% EU)

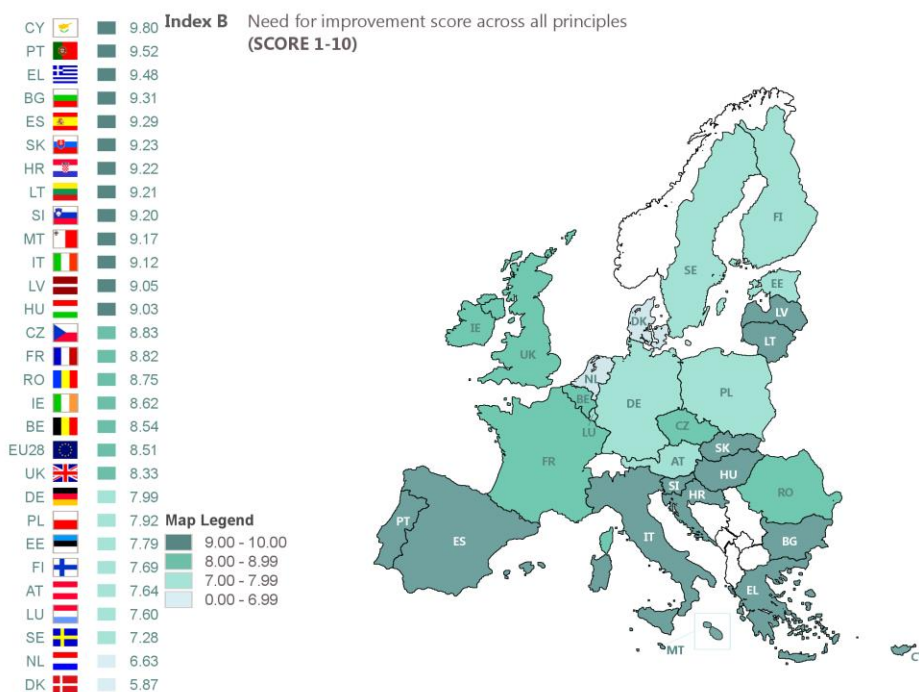
5. **A majority of respondents (52%) said that improvements were needed to some extent in their country with regard to all the 17 principles of the rule of law.** Another 47% said the situation in their country needs to be improved with regard to some of the 17 key principles. Just 1% of respondents believe that the situation regarding none of the principles needs to be improved in their country.

Index 2 Share of respondents who selected a given number of principles as needing to be improved (% - EU)



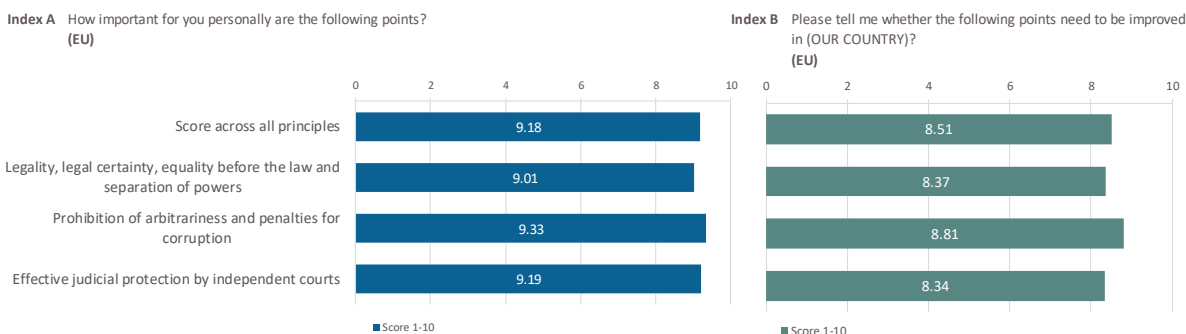

6. **Taken together, these principles of the rule of law have a need for improvement score of 8.51 out of 10.** The need for improvement score ranges from 5.87 in Denmark to 9.80 in Cyprus. There is greater variation in the extent to which respondents consider that improvements are needed in the situation in their countries with respect to the principles of rule of law compared to the perception of the importance of the principles.

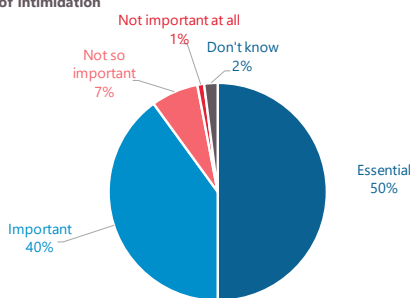
7. **The perception of importance is high across all the three major areas of rule of law** as shown by the index of perceived importance which is above 9 points (out of 10) for all the areas. **Similarly, the perception of the need for improvement is high across all three areas.** The score is above 8.3 points (out of 10) for each of the areas.



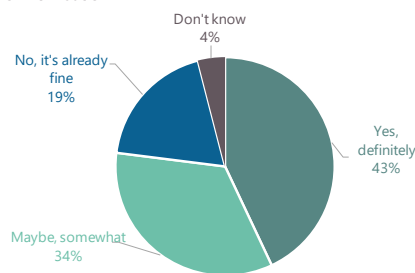

8. **A vast majority of respondents considers it important or essential that the media and journalists (90% of respondents) as well as civil society organisations and activists (87% of respondents) can criticise the government or major economic interests without the risk of intimidation.** Similarly, a vast majority considers that there is need for improvement to some extent in their country regarding the fact that media and journalists (77% of respondents) and civil society organisations and activists (73% of respondents) can criticise the government or major economic interests without the risk of intimidation.

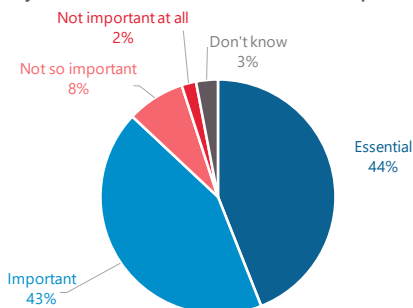
Q7.1 How important for you personally are the following points? Media and journalists can criticise the government or major economic interest without risk of intimidation (% - EU)



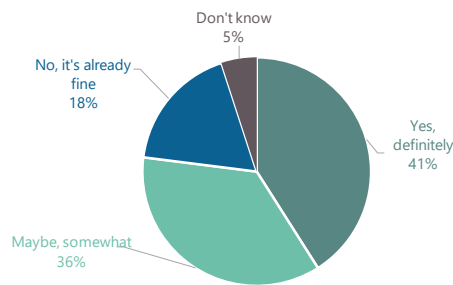

Q7.3 How important for you personally are the following points? Civil society organisations and activists can operate freely and criticise the government or major economic interest without adverse consequences (% - EU)



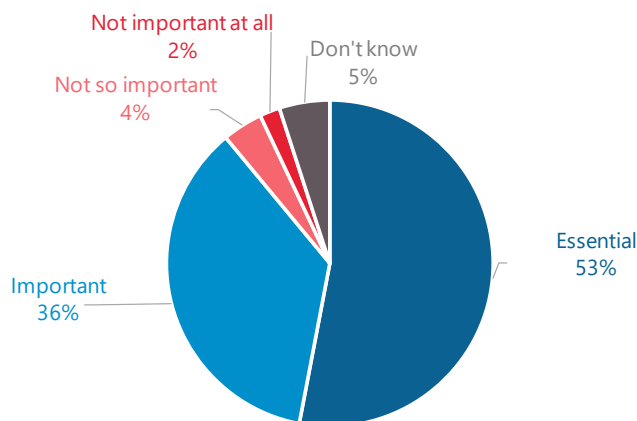

9. A large majority of respondents (89%) considers it important or essential that all EU Member States respect the core values of the EU, including fundamental rights, the rule of law and democracy.

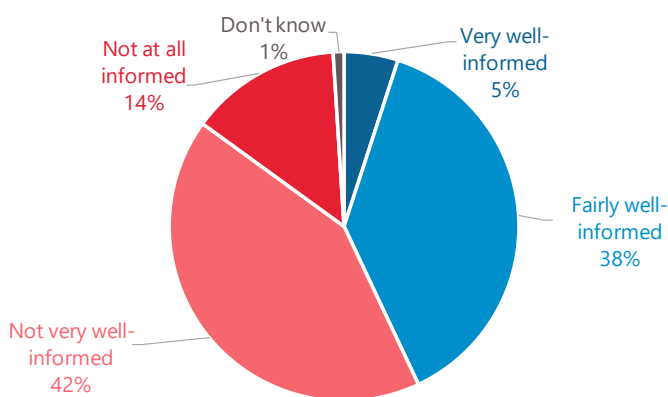
Q9.1 How important for you personally are the following points?

10. The majority of respondents does not feel sufficiently well informed about the EU’s fundamental values. Almost six in ten respondents (56%) say they do not feel informed about the EU’s fundamental values: 42% say they feel “not very well informed”, while 14% say they are “not at all informed”. On the positive side, more than four in ten (43%) say they feel either “fairly well” or “very well informed” about the EU’s fundamental values.⁸

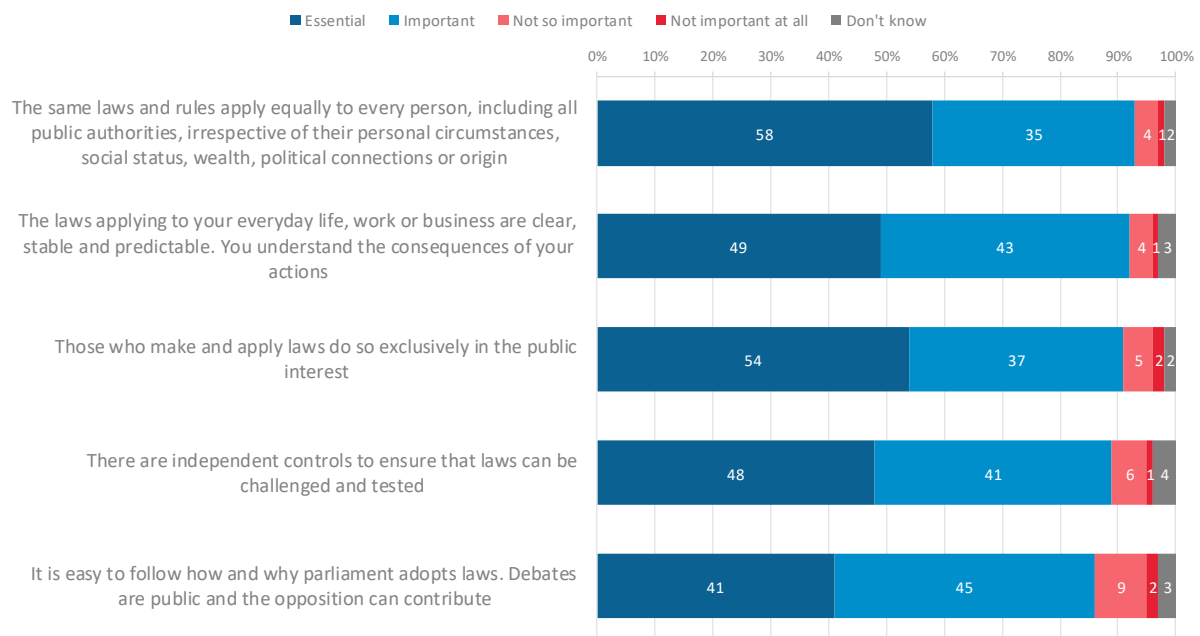
I. LEGALITY, LEGAL CERTAINTY, EQUALITY BEFORE THE LAW AND SEPARATION OF POWERS

The questions covered in this section relate to how laws are made, and whether they are clear, stable and apply in the same way to everyone. They also cover how state powers, such as governments, parliaments, and judicial systems, cooperate with and exert control on one another to ensure that decisions are taken in the public interest.

Each of the five principles of the rule of law under legality, legal certainty, equality before the law and separation of powers is seen as important by at least 86% of respondents.

More than nine in ten consider equality before the law important or essential (93%) along with 92% who think this about clarity, stability and predictability of laws and 91% who think that those who make and apply laws do so in public interest⁹. For each principle, no more than 2% think it is not important at all, further highlighting the consensus among respondents.

Q1 How important for you personally are the following points? (% EU)

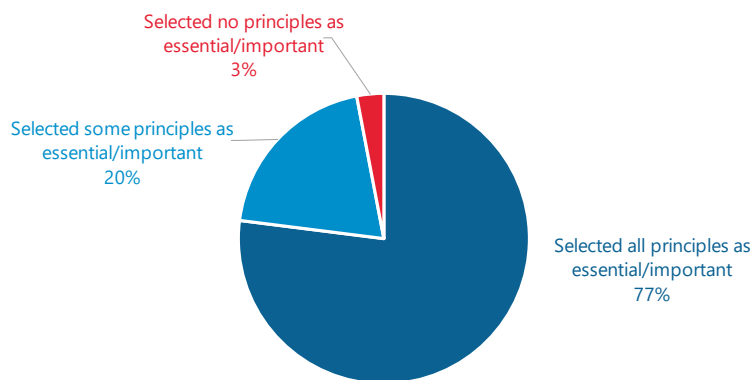

A vast majority (77%) considers that all the rule of law principles relating to legality are important or essential. Furthermore, 20% of respondents consider some of these principles as important or essential, while only 3 % consider none of them as being important or essential.

 (% - EU)

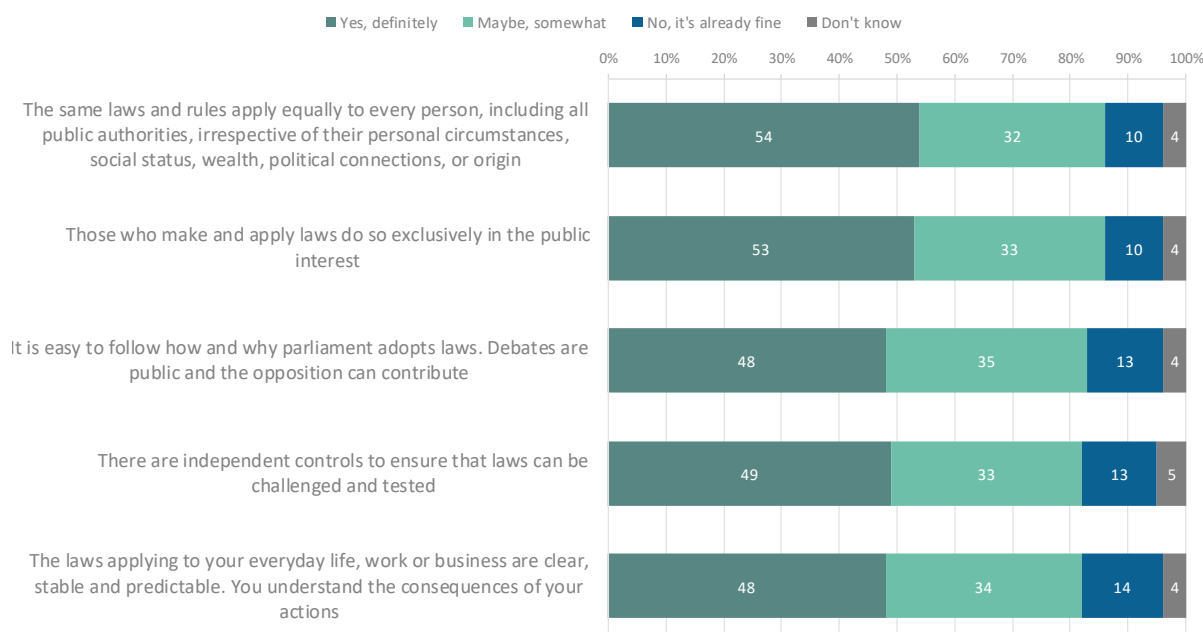

At least eight in ten think that each principle under legality, legal certainty, equality before the law and separation of powers is essential or important

A vast majority (80% or more) considers definitely or somewhat that improvement needs to be made in their country with regard to these principles of the rule of law. The figures range from 82% for clarity, stability and predictability of laws to 86% for equality before the law.

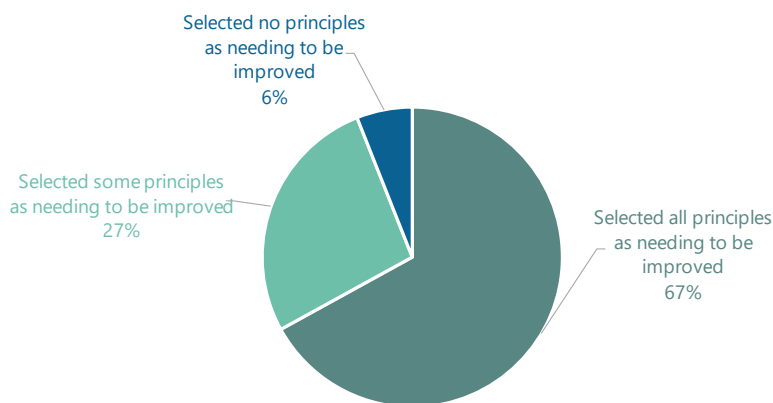
Q2 Please tell me whether the following points need to be improved in (OUR COUNTRY)?

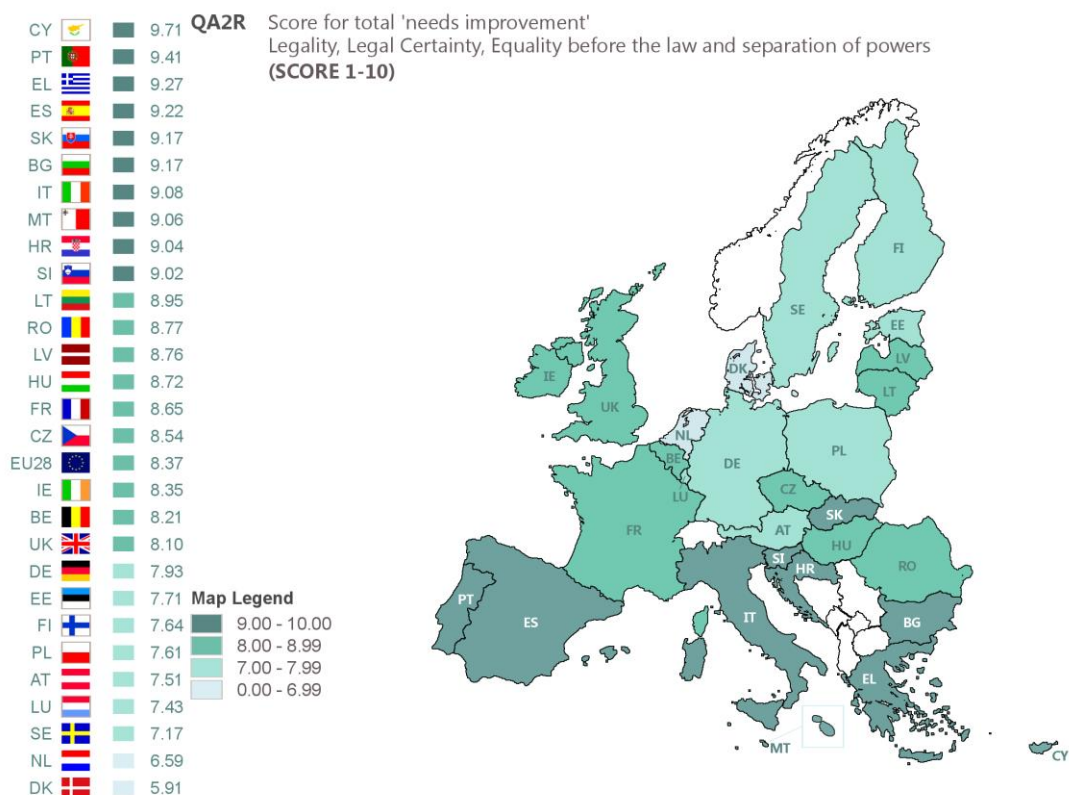
More than two thirds of persons surveyed (67%) say there is a need for improvement in their country in relation to each of the five principles of the rule of law. Another 27% say that improvement is needed in relation to at least some principles. Only 6% of respondents say that no improvement is required in their country with regard to any of the principles.

The aggregate score at EU level for the perceived need for improvement is 8.37 out of 10. As for importance, the score for respondents who think (definitely or somewhat) improvement is needed in relation to these principles is high in all EU Member States, although the results show more variation among countries than those for perceived importance. The need for improvement score ranges from 5.91 in Denmark and 6.59 in the Netherlands to 9.22 in Spain, 9.27 in Greece, 9.41 in Portugal and 9.71 in Cyprus.

Perceived importance of the principles: national results

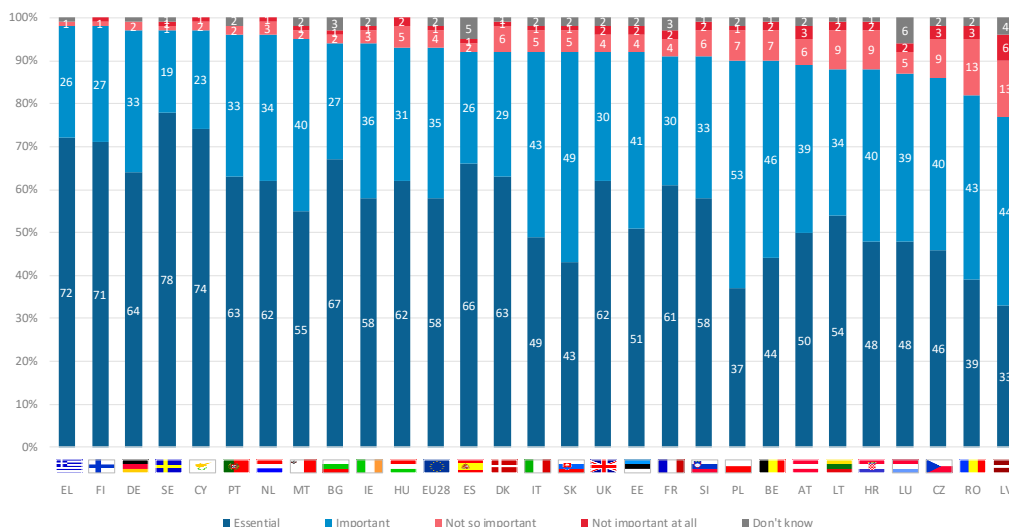
As mentioned before, the perceived importance of each of these five principles of rule of law is high in all countries. In each country, and for each principle, more than two thirds of respondents think that the given principle is essential or important.

The socio-demographic analysis shows a uniformity of opinion across groups, with no notable differences in the proportions who think each principle is important or essential.¹⁰

Equality before the law is seen as essential or important for 93% of all EU 28 respondents.

The proportion thinking this principle is essential or important ranges from 77% in Latvia, 82% in Romania and 86% in Czechia to 97% in Germany, Cyprus and Sweden and 98% in Greece and Finland. In 19 countries, more than a half believe that this principle is essential.

The same laws and rules apply equally to every person, including all public authorities, irrespective of their personal circumstances, social status, wealth, political connections or origin (% EU)

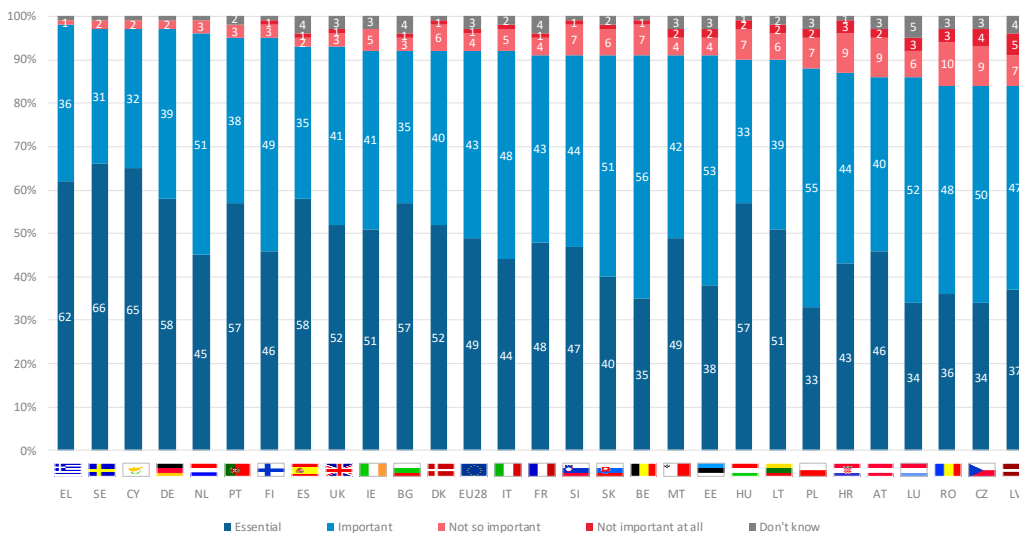

Clarity and stability of the law is seen as essential or important by 92% of all EU28 respondents. The proportion thinking this principle is essential or important ranges from 84% in Czechia, Latvia and Romania to 97% in Germany, Cyprus and Sweden, and 98% in Greece. In 12 countries, a majority thinks that the principle of clarity and stability of the laws is essential.

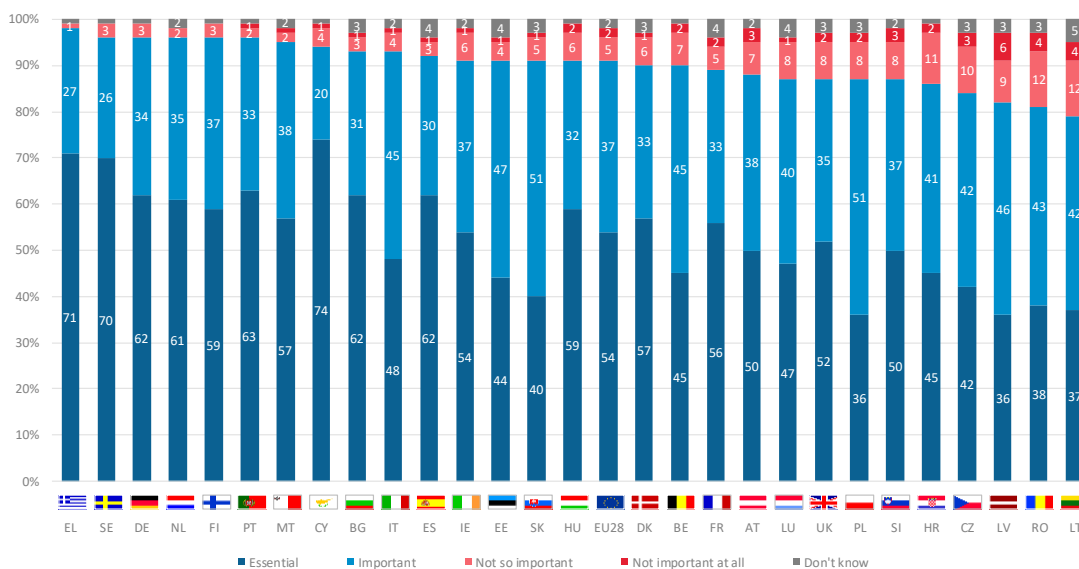
Q1.2 How important for you personally are the following points?

Lawmakers acting in the public interest is considered important or essential by 91% of EU28 respondents. The proportion thinking this principle is essential or important ranges from 79% in Lithuania, Romania (81%) and Latvia (82%) to 98% in Greece and 96% in Germany, the Netherlands, Portugal, Finland and Sweden. In 18 Member States, 50% or more believe that this principle is essential.

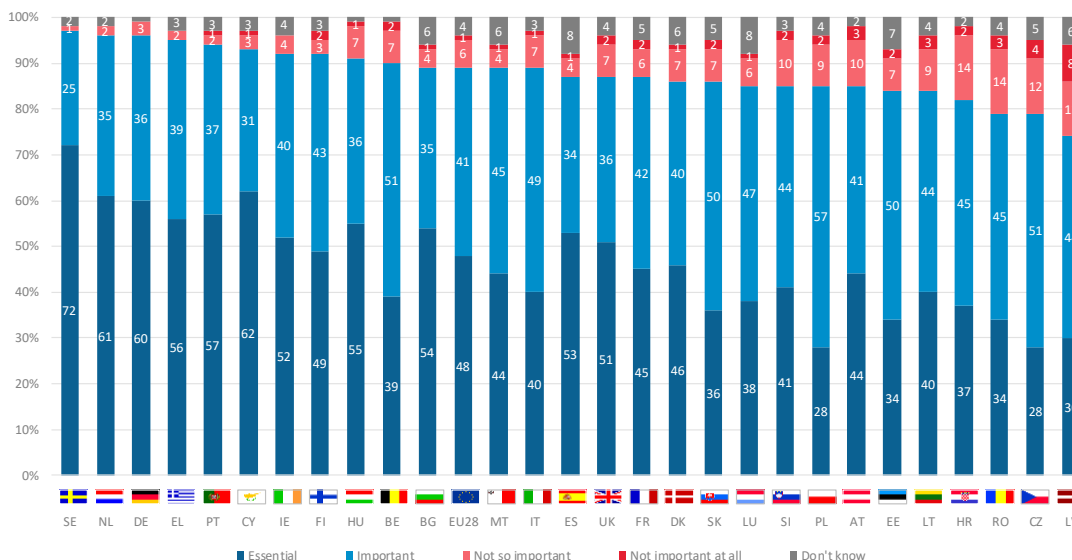
Q1.4 How important for you personally are the following points?

The existence of independent controls to challenge the laws is viewed as essential or important by 89% of all EU 28 respondents. The proportion considering this principle essential or important varies from 74% in Latvia and 79% in Czechia and Romania to 97% in Sweden and 96% in Germany and the Netherlands. In 10 countries, a majority thinks that the principle is essential.

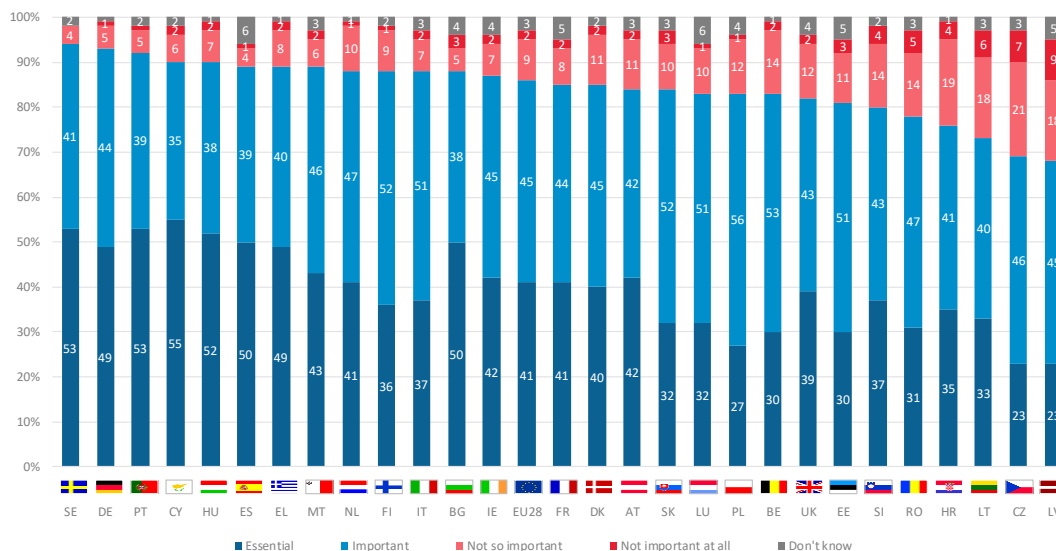
Q1.5 How important for you personally are the following points?

The ease of following how parliament adopts laws is seen as essential or important by 86% of respondents in the EU 28. The proportion who think this principle is essential or important ranges from 68% in Latvia, 69% in Czechia and Romania to over 90% in Sweden (94%), Germany (93%) and Portugal (92%). In 6 countries, more than a half deems the principle as essential.

It is easy to follow how and why parliament adopts laws. Debates are public and the opposition can contribute (% EU)



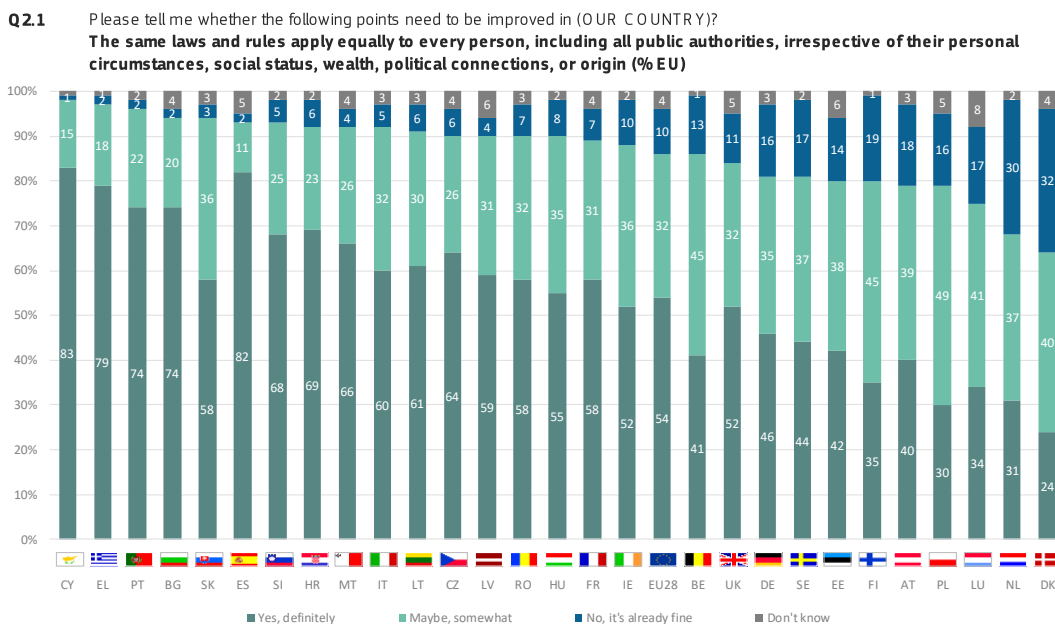

Perceived need for the improvement of the situation: national results

For all the principles of the rule of law covered in this section, the majority of respondents in each country (those who answer “yes, definitely” and “maybe, somewhat”) thinks there needs to be at least some improvement in their situation.¹¹ However, the variation in these proportions between countries is larger than the variation for perceived importance. In addition, in some countries there is a substantial share of respondents who think the situation is already fine in their country.

As was the case for importance, the socio-demographic analysis shows no notable differences within groups in the proportions who think the situation with regard to each principle needs improvement.

The situation of **equality before the law is seen as needing improvement to some extent by 86% of all EU 28 respondents.** The proportion thinking it definitely or somewhat needs improvement ranges from 64% in Denmark, 68% in the Netherlands and 75% in Luxembourg to 96% in Portugal, 97% in Greece and 98% in Cyprus. In 18 countries, a majority thinks that the situation definitely needs to be improved in their country regarding this principle.

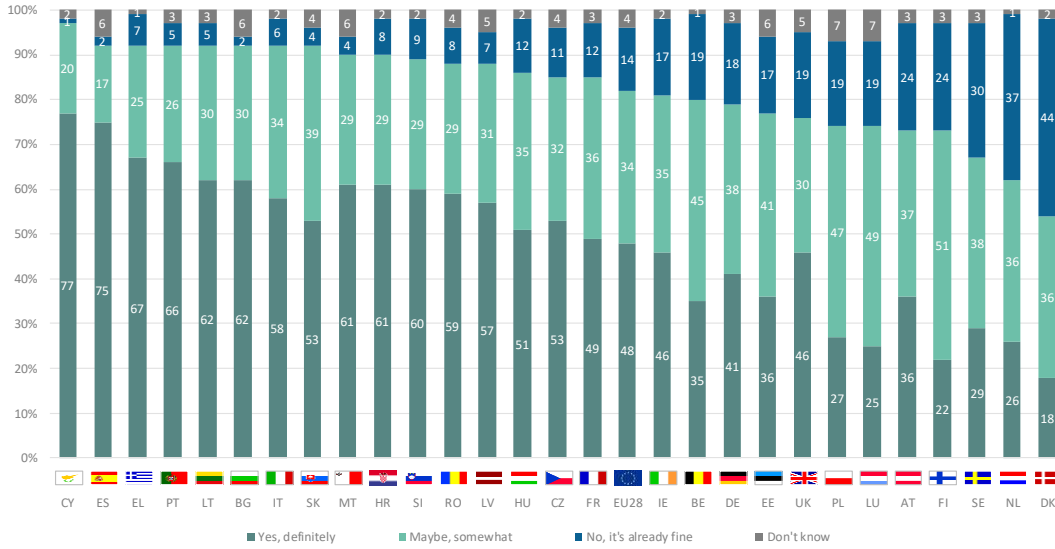

The situation regarding **clarity and stability of laws is seen as needing at least some improvement by 82% of respondents**. The proportion who think it definitely or somewhat needs improvement ranges from 54% in Denmark to 92% in Spain, Greece, Portugal, Lithuania, Bulgaria, Italy and Slovakia, and 97% in Cyprus. In 14 countries, more than a half believe that the situation should definitely be improved with regard to this principle.

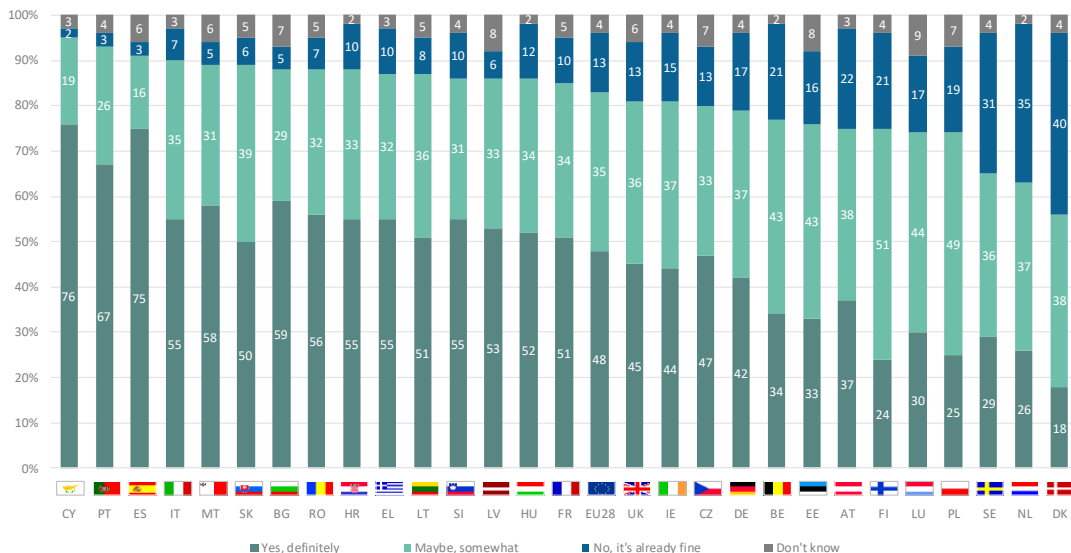
Q2.2 Please tell me whether the following points need to be improved in (OUR COUNTRY)?

The situation regarding the **ease in following how parliament adopts laws is seen as needing improvement by 83% of respondents in the EU**. The proportion who think it definitely or somewhat needs improvement ranges from 56% in Denmark to over 90% in Spain (91%), Portugal (93%) and Cyprus (95%). In 15 countries, at least a half believes that the situation pertaining to this principle definitely needs to be improved.

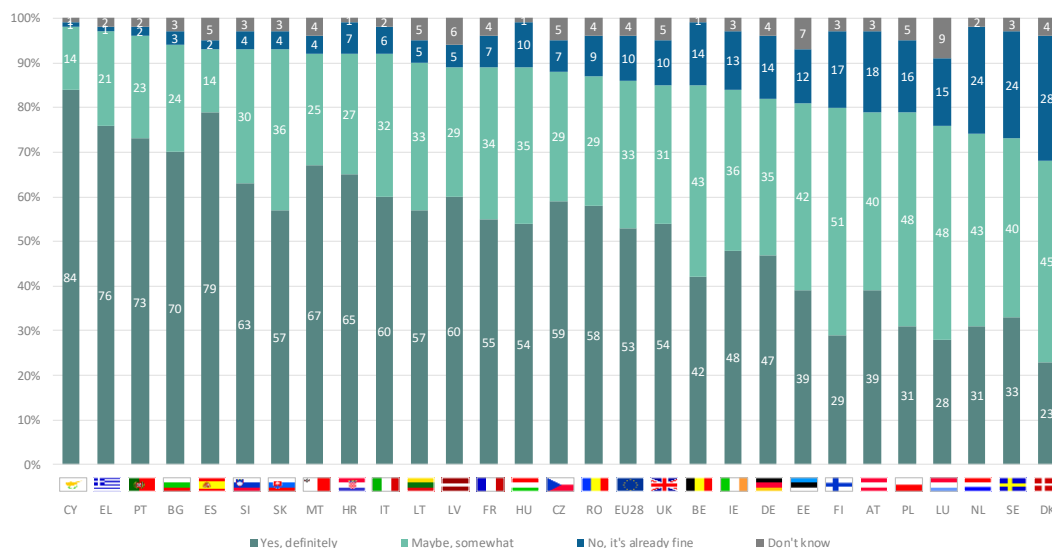
Q2.3 Please tell me whether the following points need to be improved in (OUR COUNTRY)?

The situation regarding **lawmakers acting in the public interest** is thought to need improvement to some extent by 86% of respondents. The proportion who think it definitely or somewhat needs improvement ranges from 68% in Denmark, 73% in Sweden and 74% in the Netherlands to 96% in Portugal, 97% in Greece and 98% in Cyprus. In 17 countries, a majority believes that the situation regarding this principle definitely needs improvement.

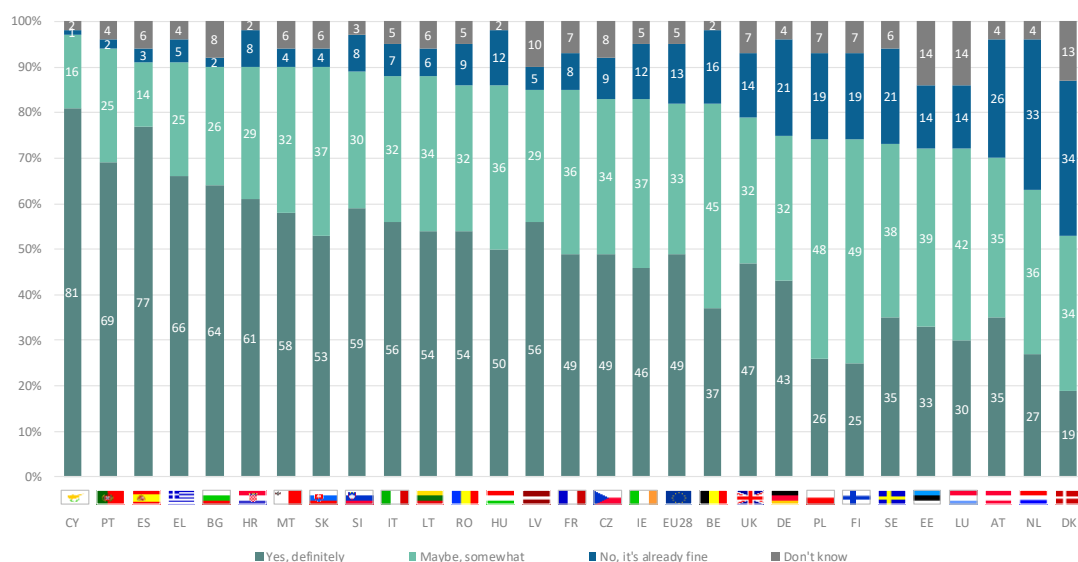
Q2.4 Please tell me whether the following points need to be improved in (OUR COUNTRY)?

The situation regarding the **existence of independent controls on law** is seen as needing improvement to some extent by 82% of all EU28 respondents. The proportion thinking it definitely or somewhat needs improvement ranges from 53% in Denmark, 63% in the Netherlands and 70% in Austria to 93% in Spain, 94% in Portugal and 97% in Cyprus. In half of the countries, a majority believes that the situation regarding this principle should be improved.

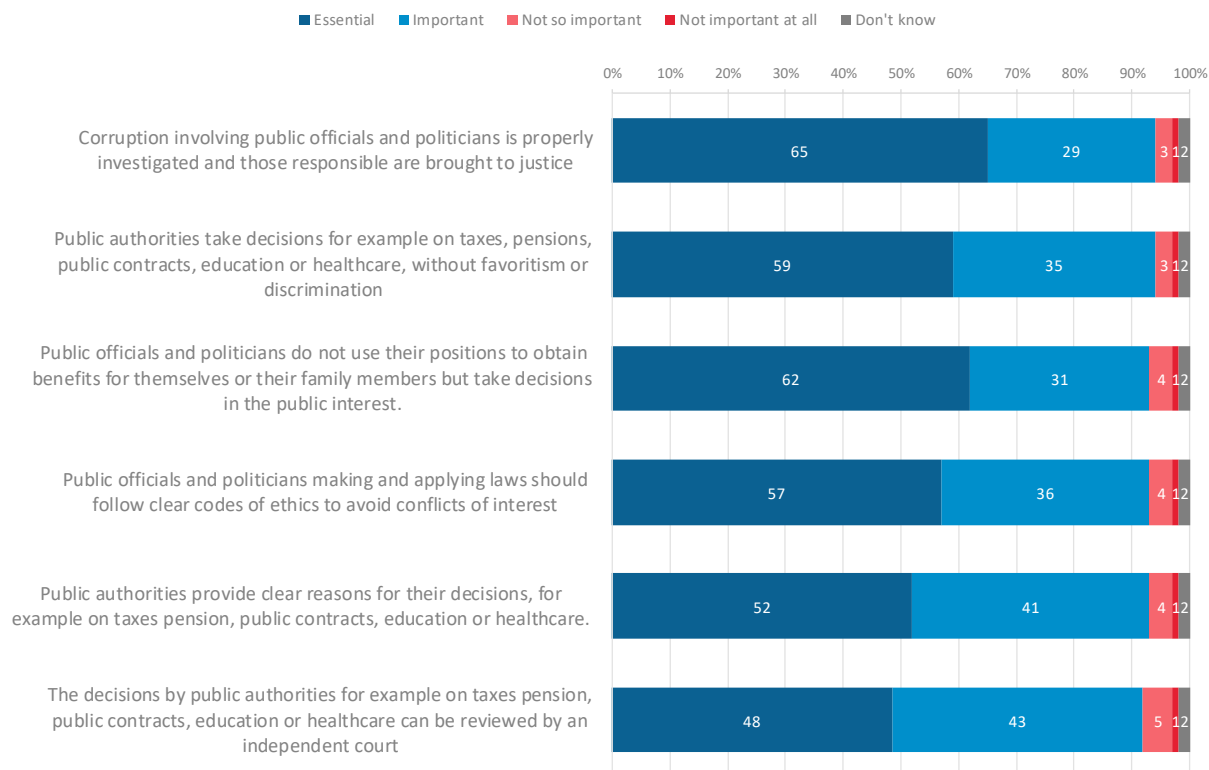
II. PROHIBITION OF ARBITRARINESS AND PENALTIES FOR CORRUPTION

This section of the report considers the importance of principles of rule of law broadly relating to the prohibition of arbitrariness and penalties for corruption, as well as the perceived need for improvement in this area. The principles cover subjects such as whether public authorities make their reasons for decisions clear, and whether these decisions are made in an unbiased way and in the public interest. The availability of an independent review on the decisions of public authorities, the proper investigation of corruption, and a code of ethics for those making and applying laws are other topics that are considered.

Each of the six principles under the prohibition of arbitrariness and penalties for corruption is considered important by at least 91% of respondents

More than nine in ten respondents think each principle of the rule of law in this section is essential or important to them, with minor differences seen among principles.¹² In each case, just 1% say each principle is not important at all.

(% EU)

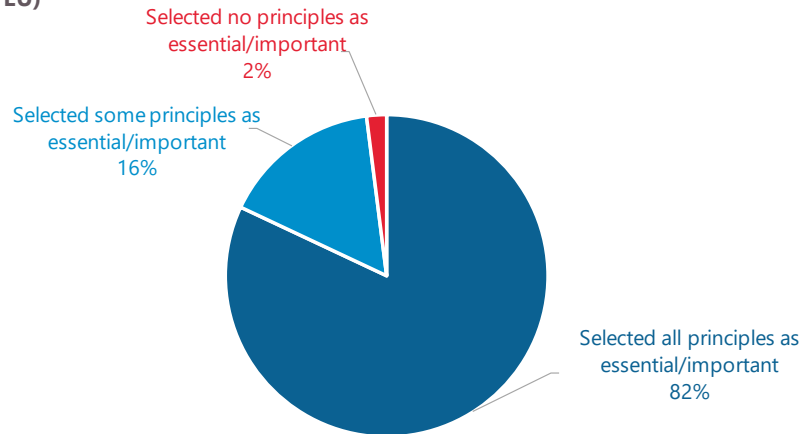

Looking at the share of respondents who selected all the principles of prohibition of arbitrariness as essential or important, more than four in five (82%) have done so, indicating strong agreement as to the importance of all principles in this set. A further 16% selected some principles as important or essential and only a small share (2%) considered none of the principles to be essential or important.

(% - EU)

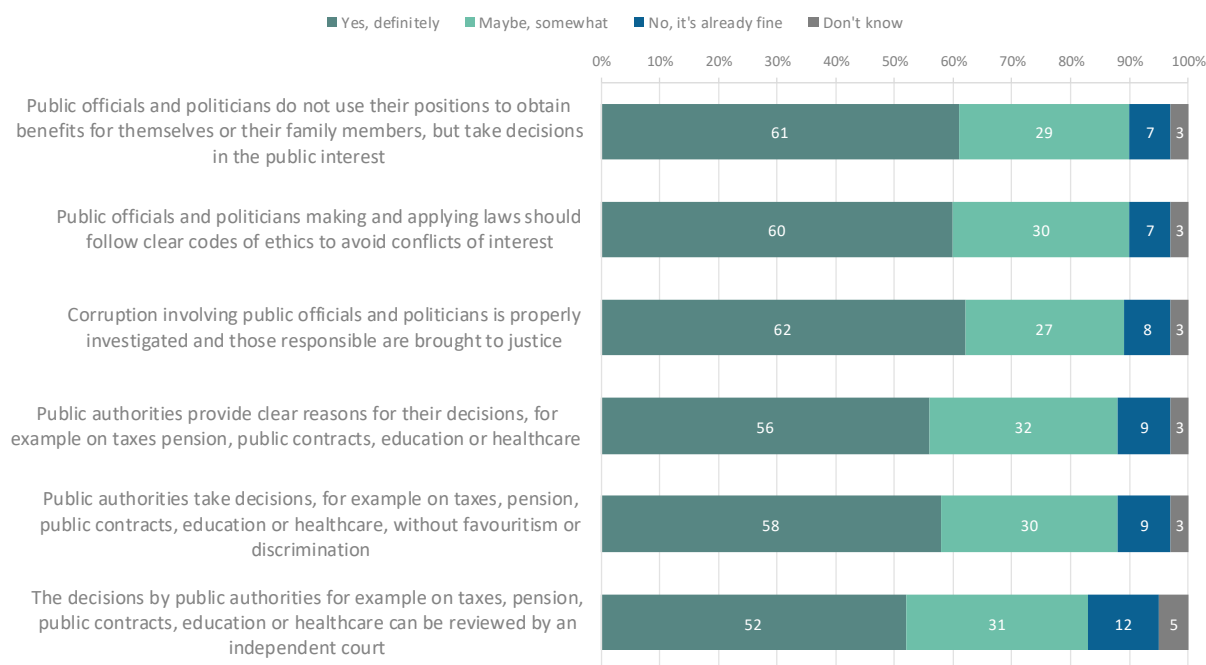

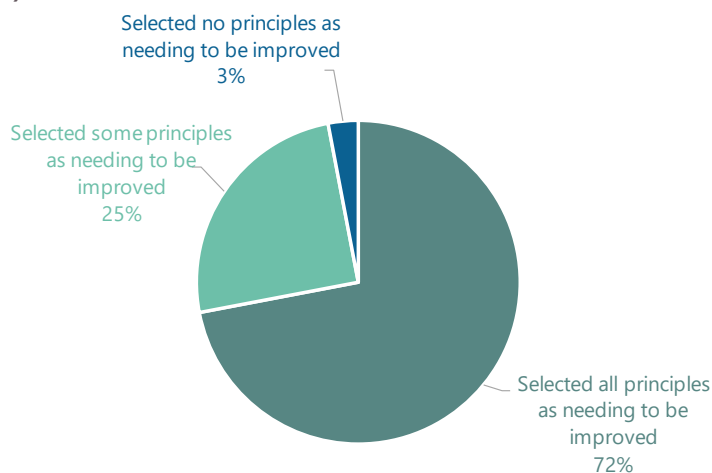

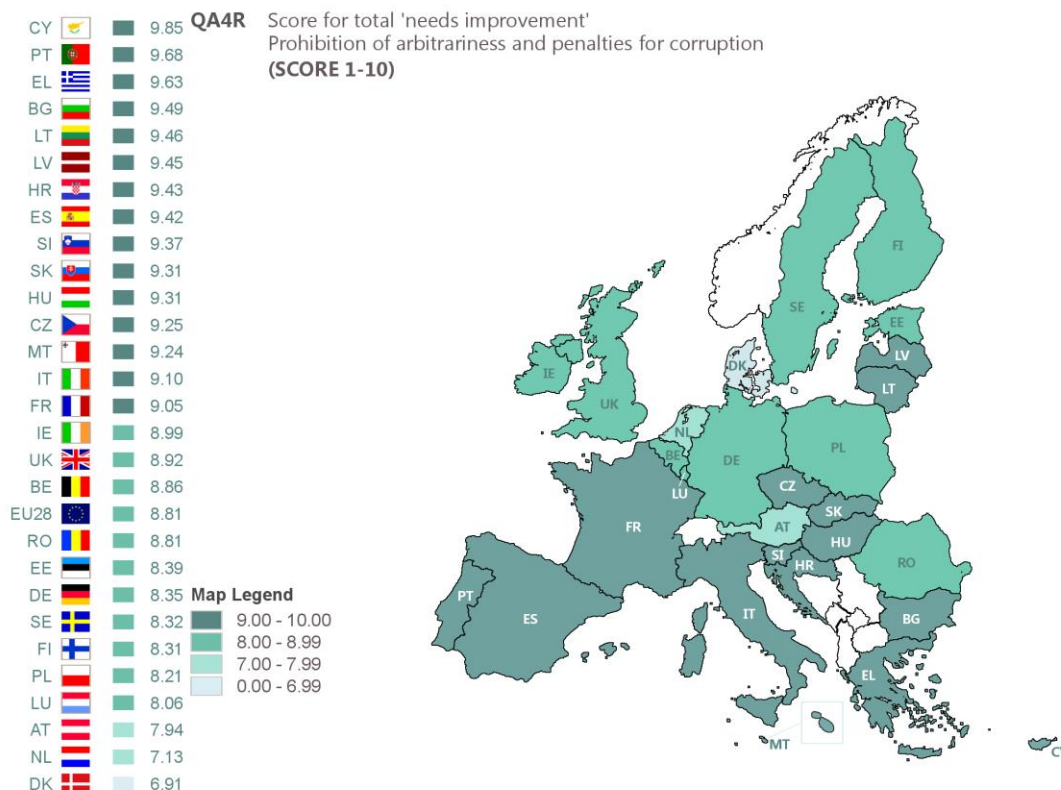
Close to three quarters of respondents believe that in their countries the situation regarding all of the principles under the prohibition of arbitrariness should be improved to some extent, while 25% believe that some of these principles need improvement. Only 3% stated that, in their opinion, the situation pertaining to none of the principles should be improved.

The need for improvement score is also relatively high across all Member States, although the results show a higher level of variation than for perceived importance. The need for improvement score ranges from 6.91 in Denmark, 7.13 in the Netherlands and 7.94 in Austria to 9.63 in Greece, 9.68 in Portugal and 9.85 in Cyprus.

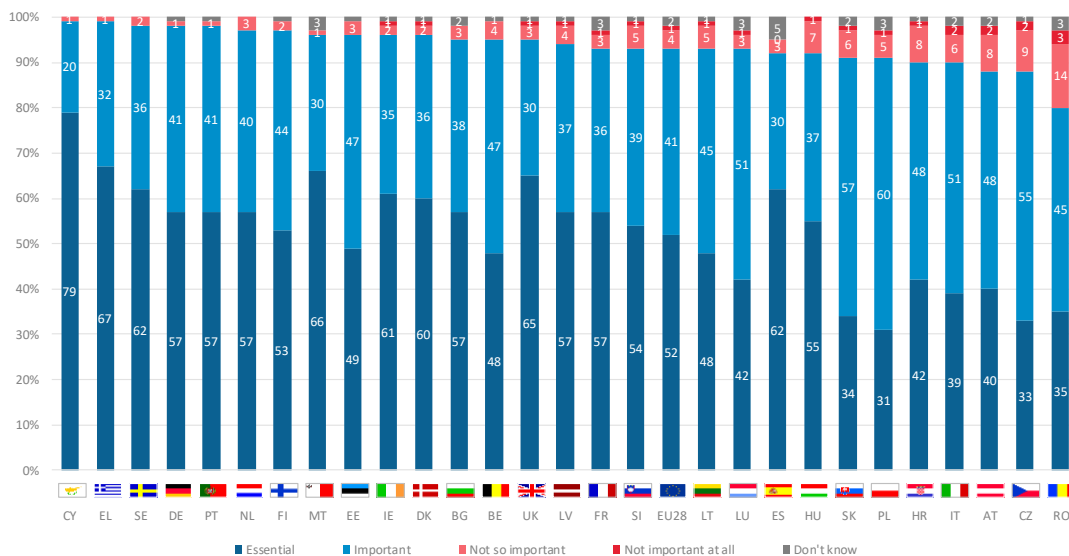
Perceived importance of the principles: national results

The perceived importance of each of these six principles of rule of law is high in all countries. In each country, and for each principle, more than two thirds of respondents think that the given principle is essential or important.

The socio-demographic analysis shows a consensus of opinion across groups, with no notable differences in the proportions who think each principle is important.

The clarity of public authorities' decisions is seen as essential or important by 93% of all the EU28 respondents. The proportion who think this principle essential or important ranges from 80% in Romania and 88% in Czechia and Austria to 98% in Germany, Sweden and Portugal, and 99% in Greece and Cyprus. In 17 countries, a majority thinks that this principle is essential.

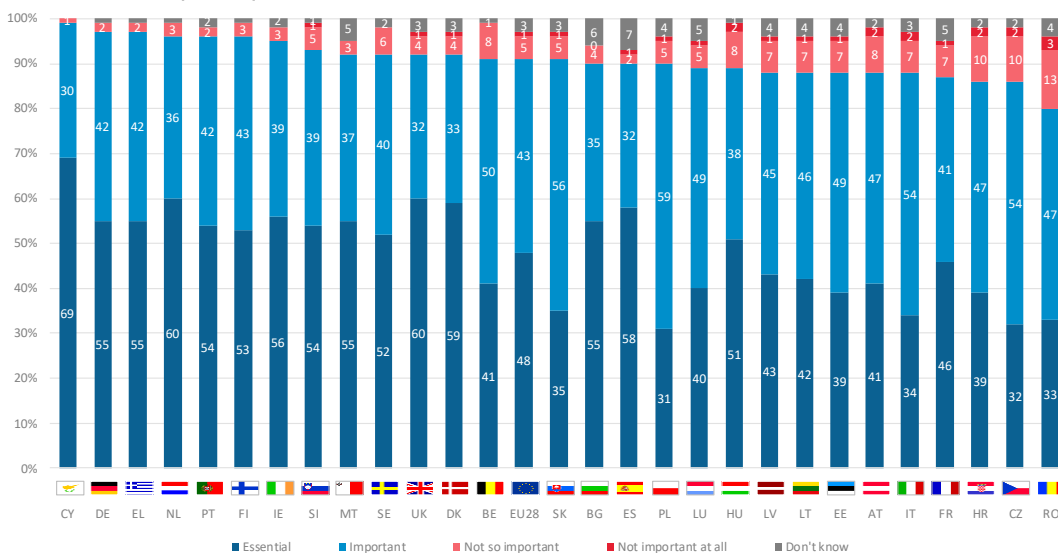

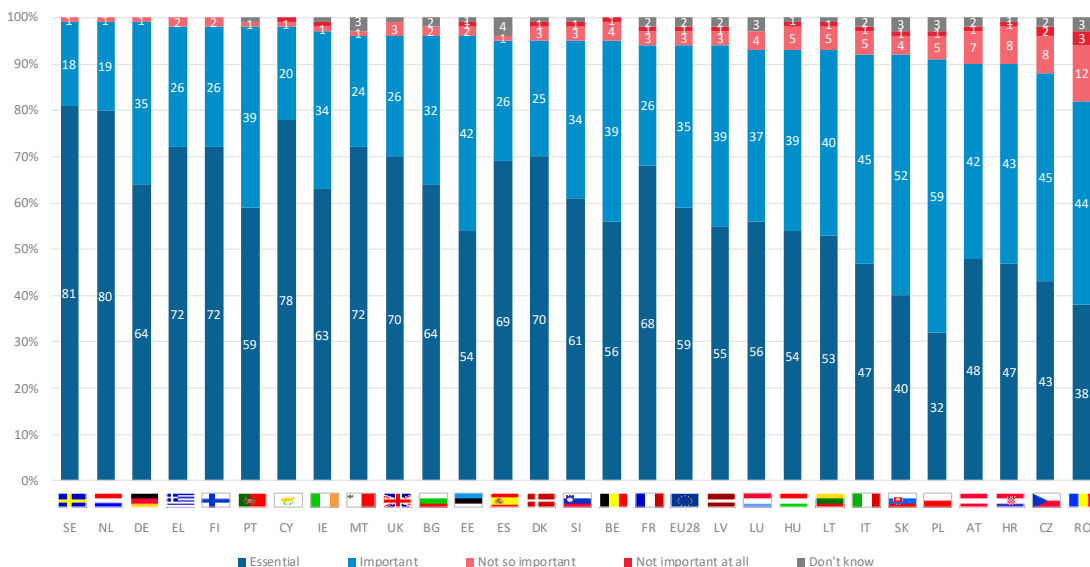

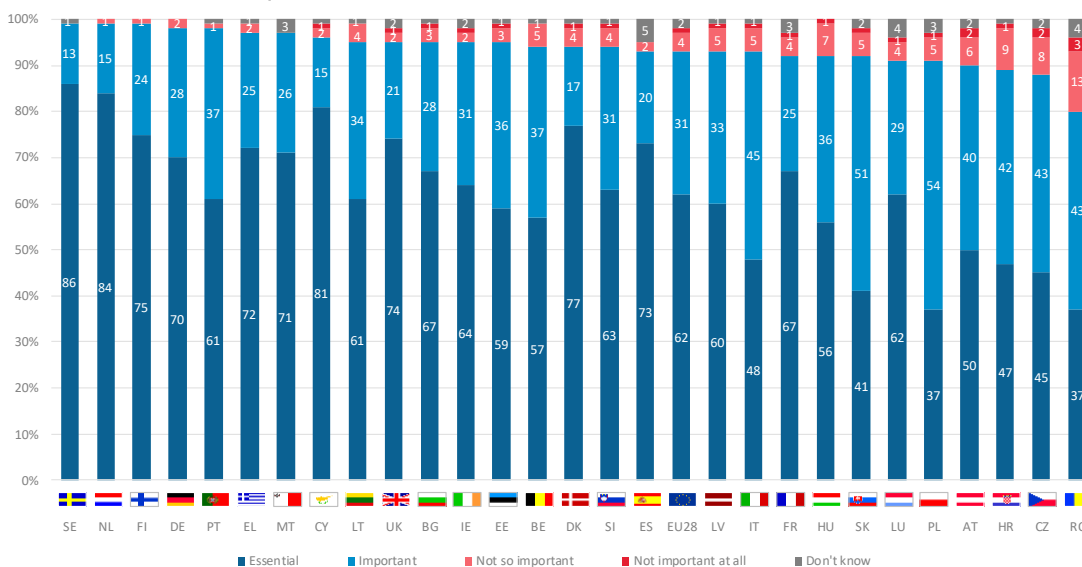

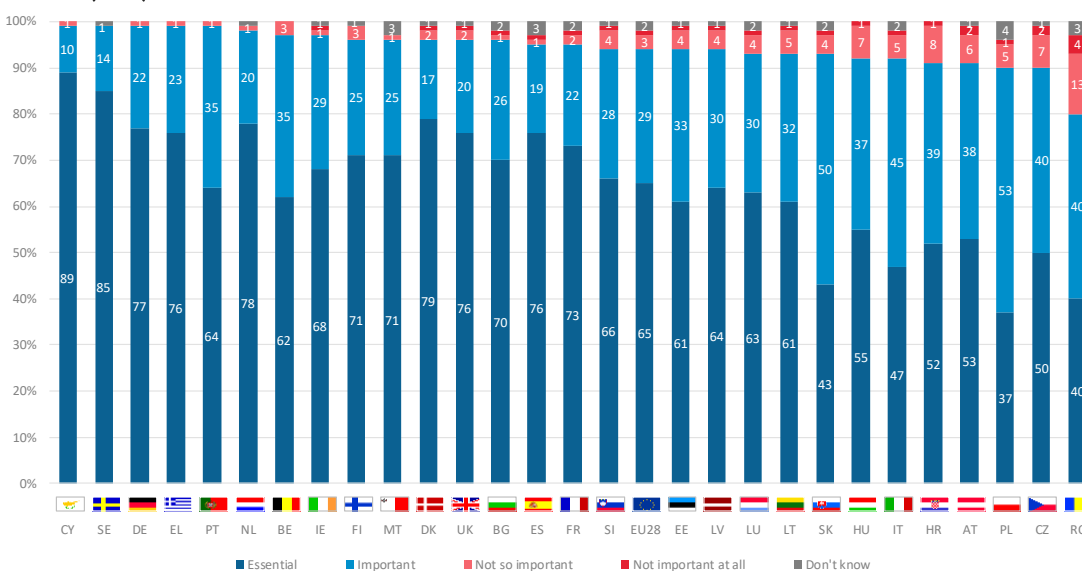

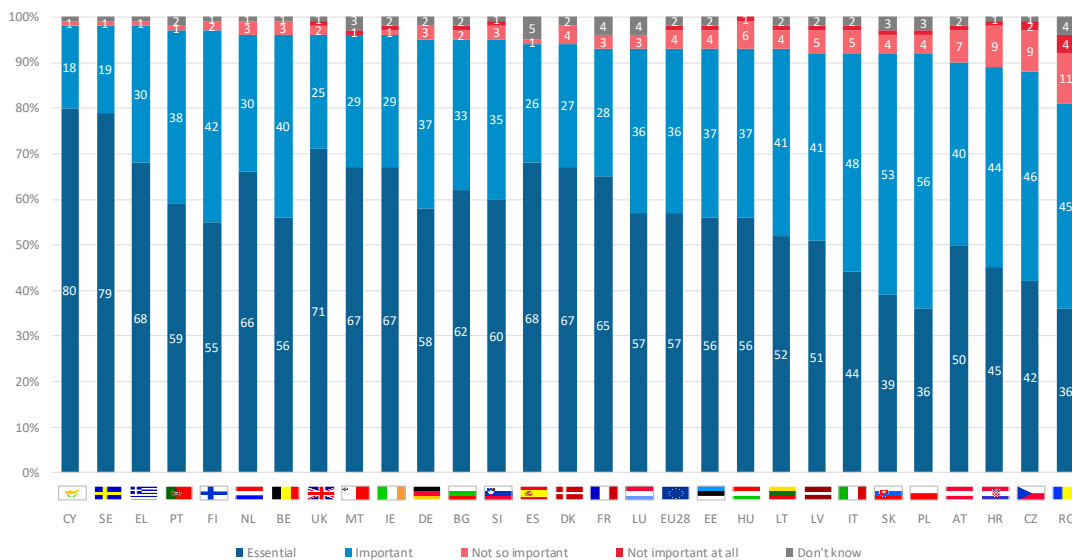
Q3.5 How important for you personally are the following points?

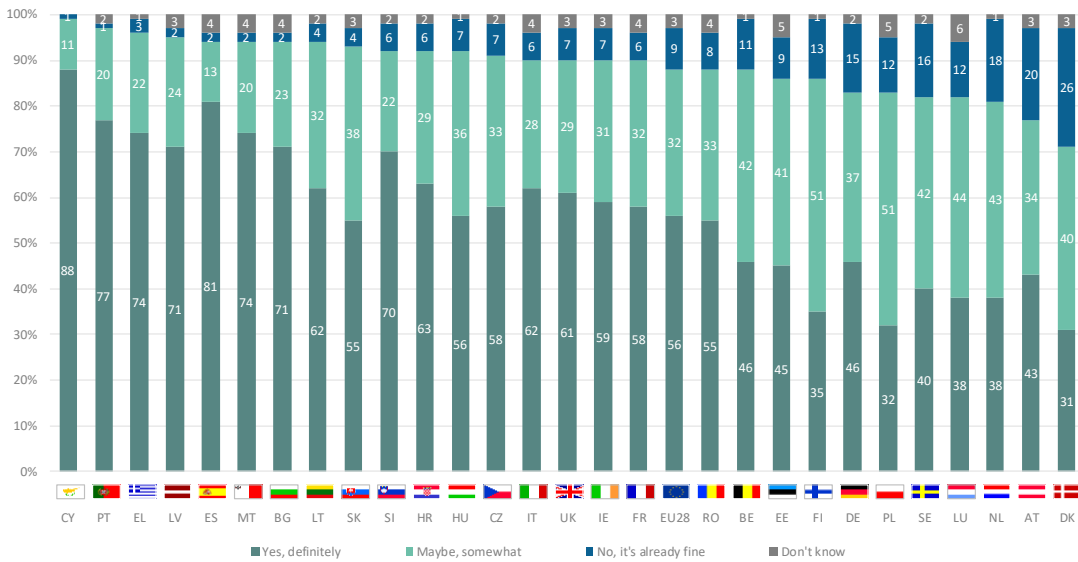
Perceived need of improvement of the situation: national results

At a national level, there is more variation in the proportion of respondents who think the situation of these principles needs to be improved in their country, compared to the range for perceived importance. However, for each principle, the majority in each country thinks there needs to be improvement (those who answer “yes, definitely” and “maybe, somewhat”). In some countries, there is also a notable proportion of respondents considering the situation is already fine in their country.

As was the case for importance, the socio-demographic analysis shows no large differences within groups in the proportions who think the situation with regard to each principle needs improvement.

The situation regarding the **clarity of public authorities’ decisions is seen as needing improvement to some extent by 88% of all EU28 respondents**. The proportion thinking it definitely or somewhat needs improvement ranges from 71% in Denmark, 77% in Austria and 81% in Finland to 96% in Greece, 97% in Portugal and 99% in Cyprus. In 18 countries, more than a half of respondents think that the situation definitely needs improvement.

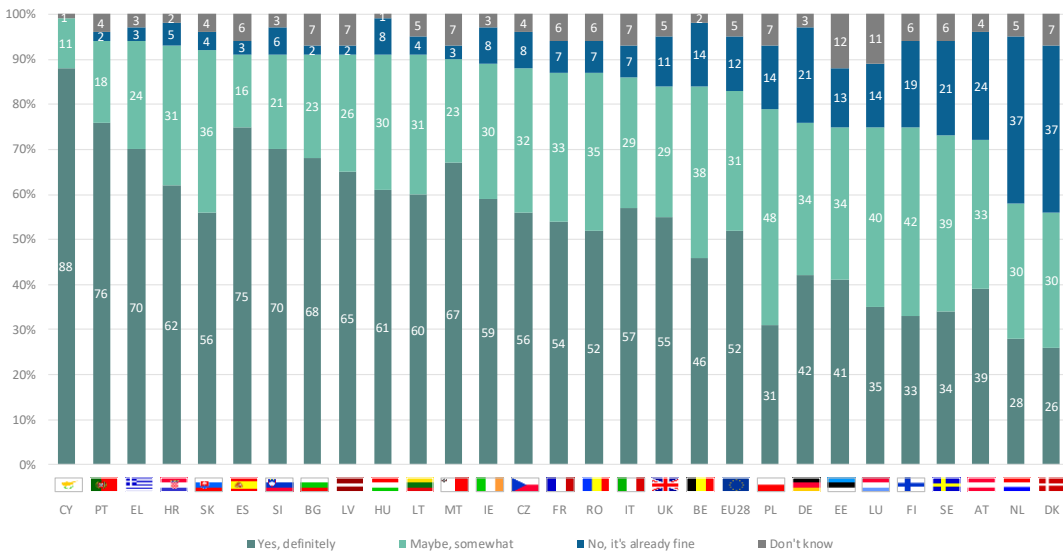

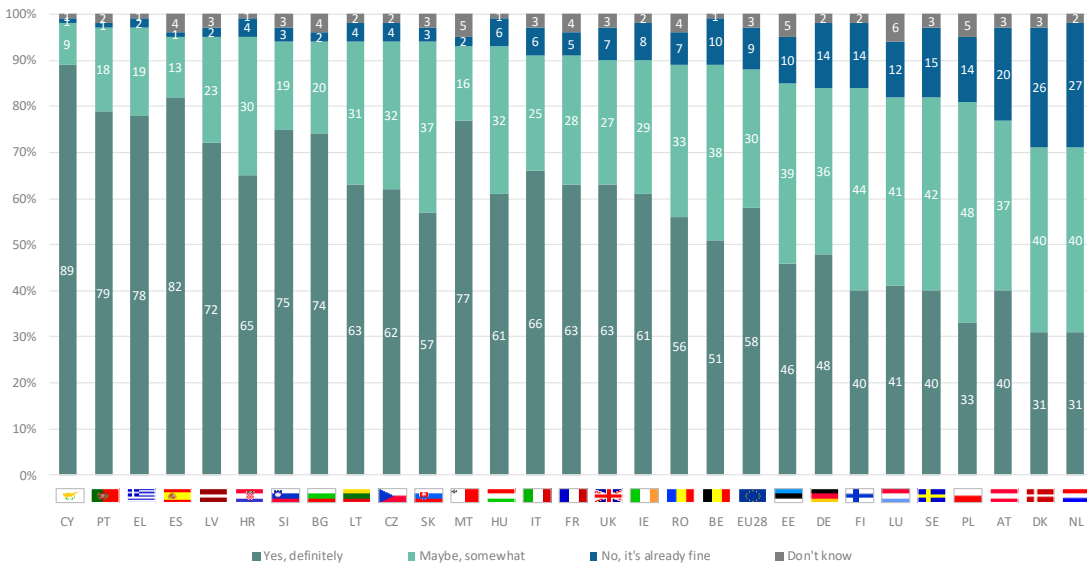

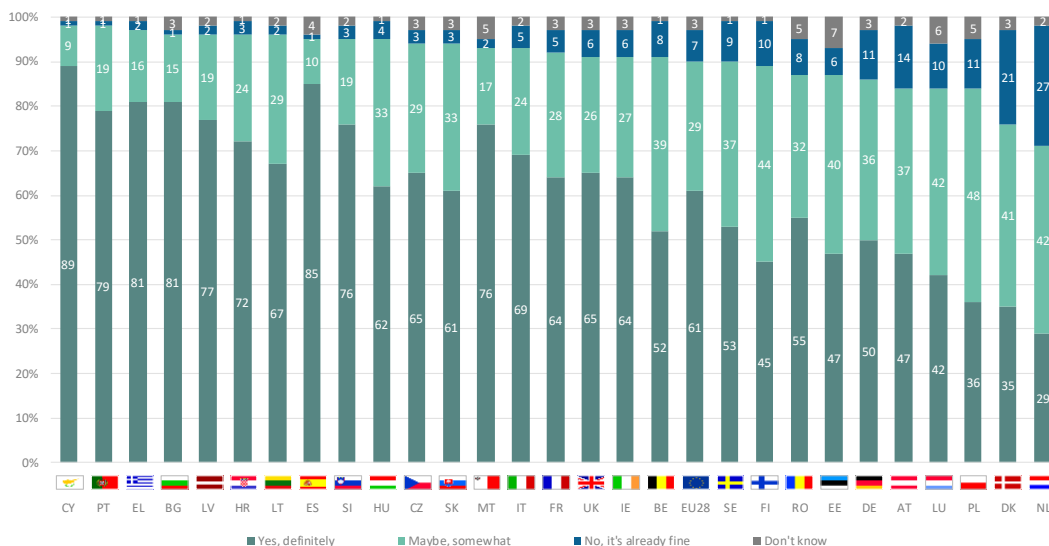

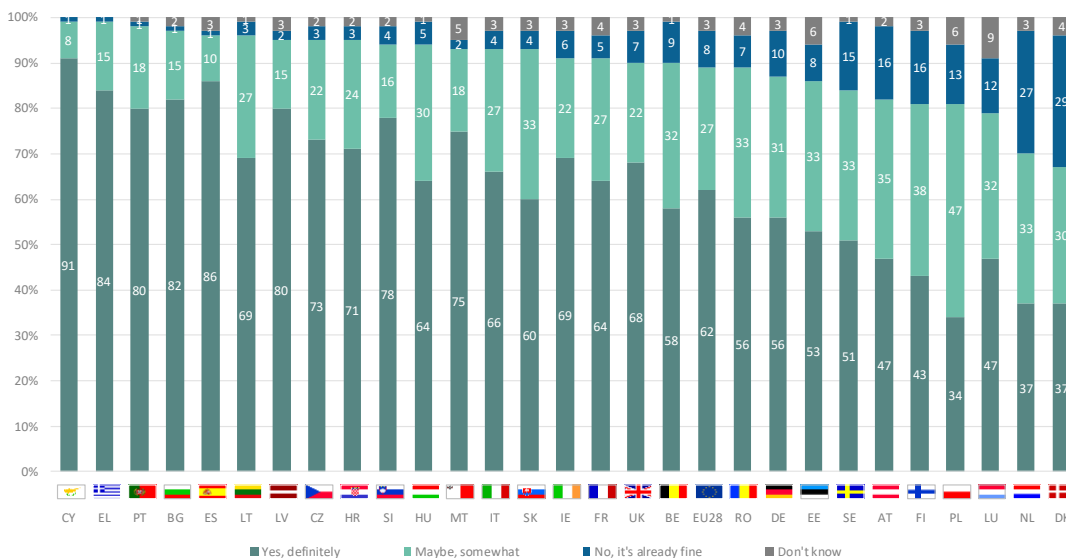

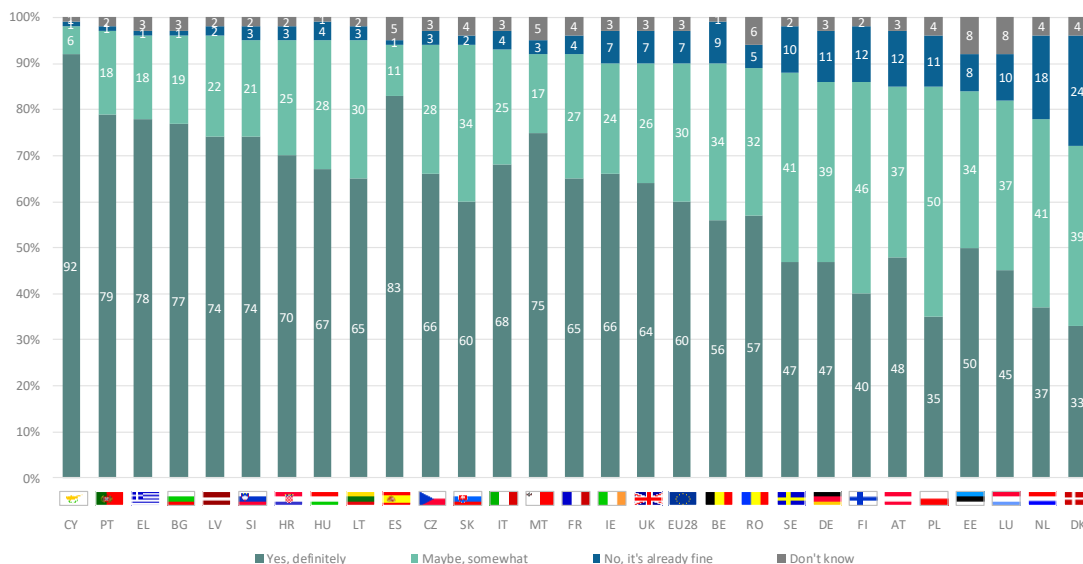

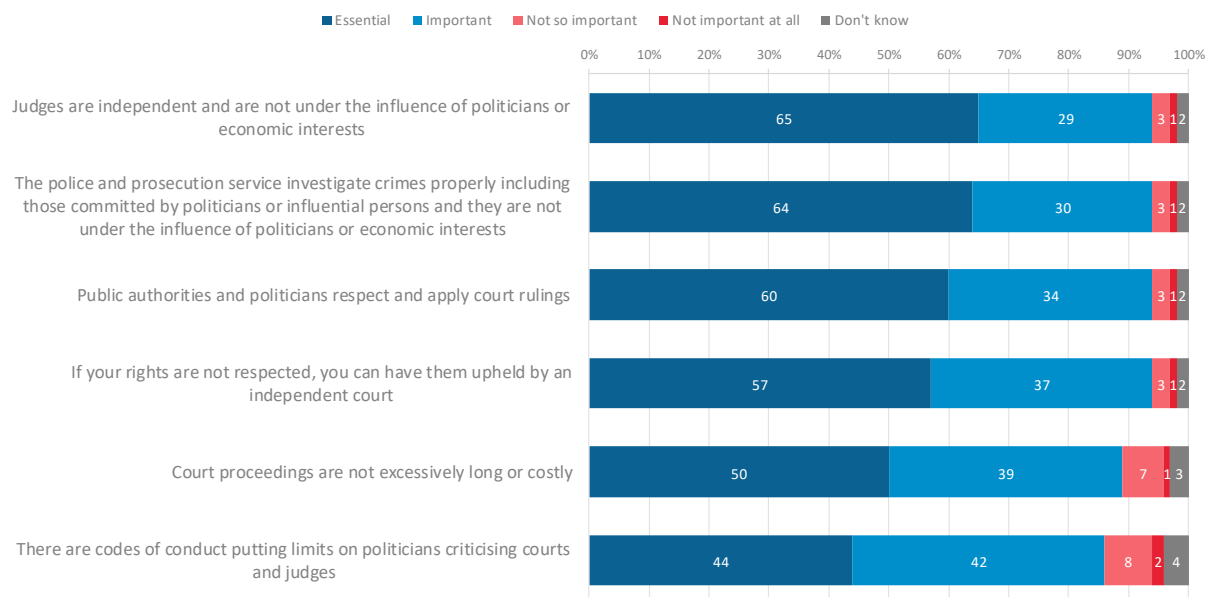
III. EFFECTIVE JUDICIAL PROTECTION BY INDEPENDENT COURTS

This section of the report focuses on principles of the rule of law relating to effective judicial protection by independent courts. The principles under this heading include issues around the independence of judges and a limit on criticism of the legal system by politicians, the proper investigation of crimes by politicians or persons of influence, and respect for court rulings. Also considered are the availability of an independent court when rights are not respected, and the length and cost of court proceedings.

Each of the six principles coming under the effective judicial protection by independent courts is considered important or essential by more than 86% of respondents

For five out of the six principles, more than nine in ten consider them as essential or important. The overall importance of each of these principles is further highlighted by the fact that for each principle no more than 2% say it is not important at all.

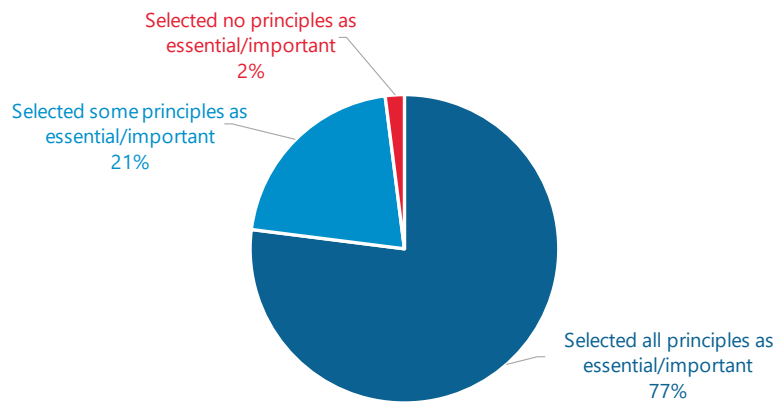
Q5 How important for you personally are the following points? (% EU)

As in the previous sections, a significant proportion of respondents, in this case 77%, believe that all the six principles of effective judicial protection are essential or important. Additionally, a further 21% think that some principles are essential or important. Only 2% selected none of the principles as being essential or important.

(% - EU)

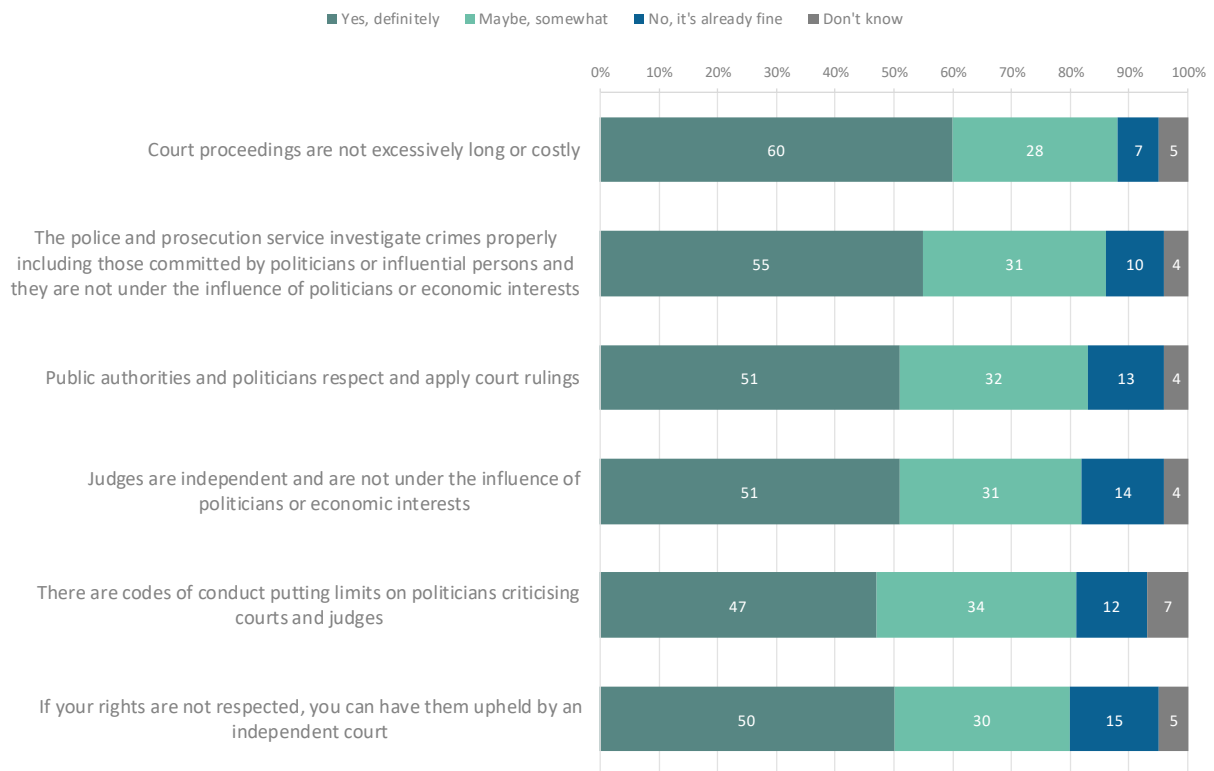

Between 80% and 88% of respondents consider definitely or somewhat that the situation in relation to principles coming under the effective judicial protection by independent courts needs to be improved in their country

At least eight in ten respondents think the situation of each principle under the effective judicial protection by independent courts needs at least some improvement (“yes, definitely” or “maybe, somewhat”), and there is relatively little difference between them: 88% think the length or cost of court proceedings needs improvement, while 80% say this about access to an independent court for claiming one’s rights¹⁴.

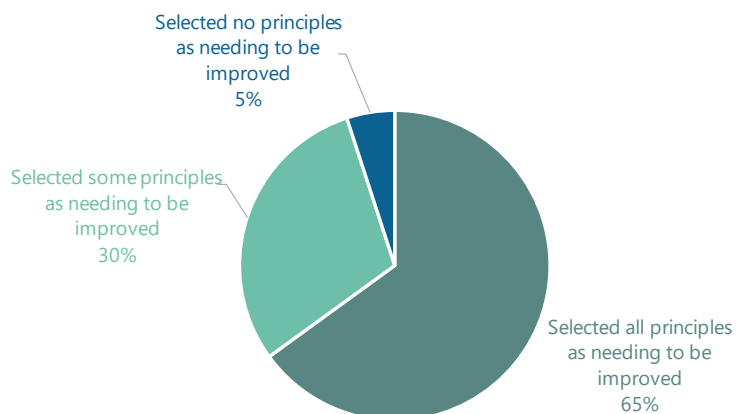

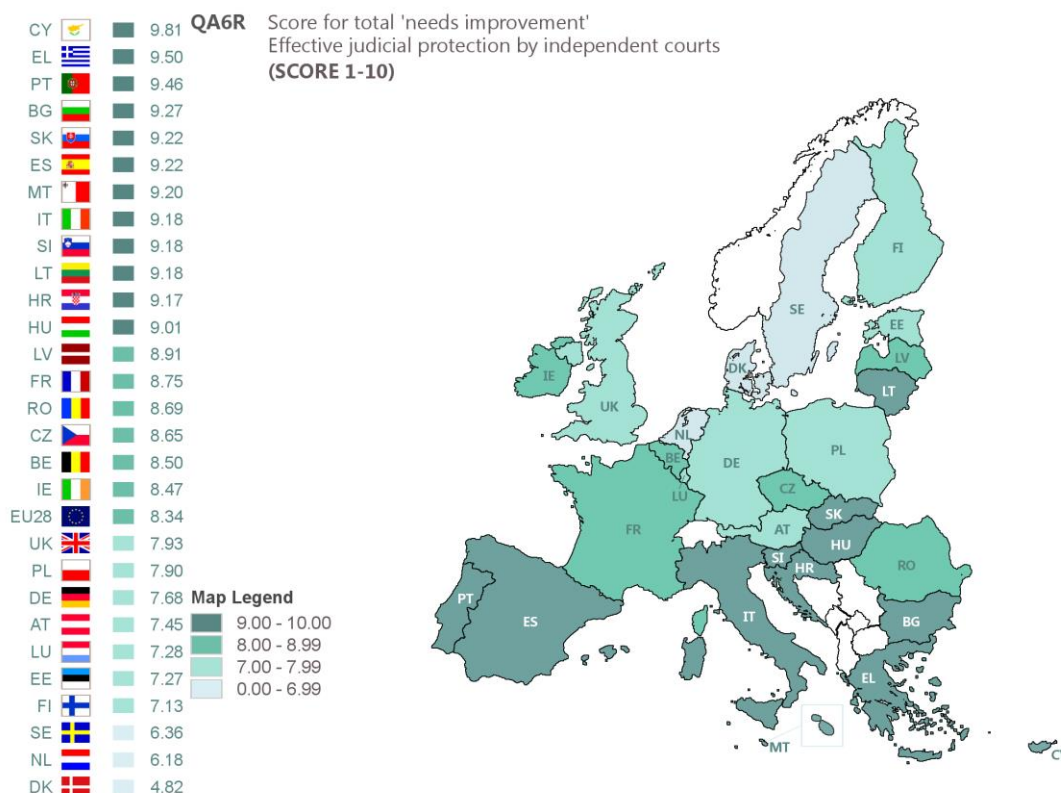
When it comes to the situation in relation to the effective judicial protection by independent courts, 65% of all respondents consider that in their country the situation regarding all the principles in this sub-set needs to be improved, and a further 30% believe that the situation regarding some of the principles requires improvement. As with other sets of principles, only a minority of 5% believes that the situation regarding none of the principles needs improvement.

The score for the perceived need for improvement of the situation for the effective judicial protection by independent courts is 8.34 out of 10. The need for improvement score ranges from 4.82 in Denmark, 6.18 in the Netherlands and 6.36 in Sweden to 9.46 in Portugal, 9.50 in Greece and 9.81 in Cyprus.

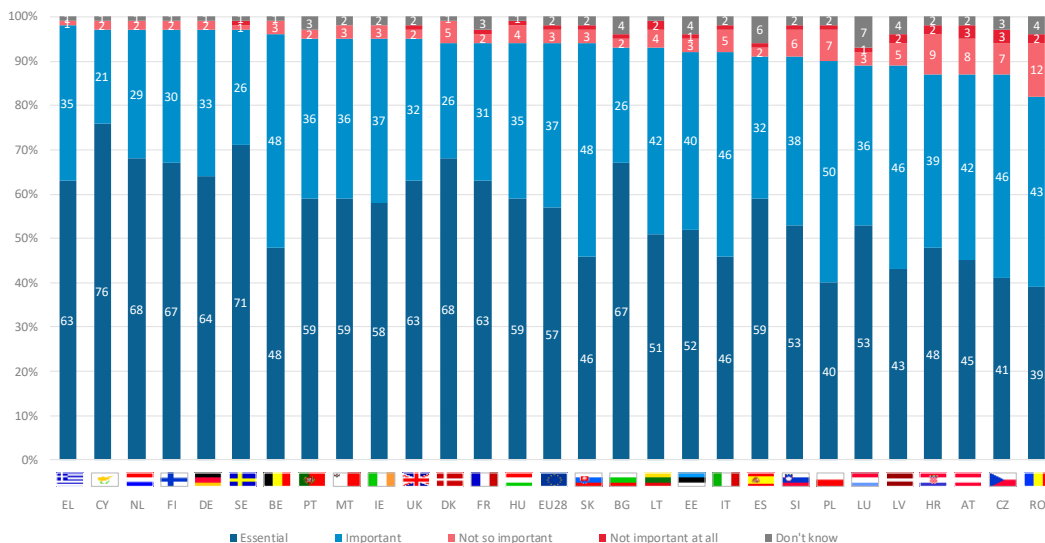
Perceived importance of the principles: national results

The national results show that each of these principles has a high level of importance in each Member State: for each principle more than seven in ten in each country say it is essential or important.

The socio-demographic analysis shows a consistency of opinion across groups, with no notable differences in the proportions who think each principle is important.

Access to an independent court is seen as important or essential by 94% of EU28 respondents. The proportion who think this principle is essential or important ranges from 82% in Romania and 87% in Czechia, Croatia and Austria to 97% in Germany, Sweden, the Netherlands, Finland and Cyprus, and 98% of respondents in Greece. The proportion who consider this principle essential is greater than 50% in 19 countries.

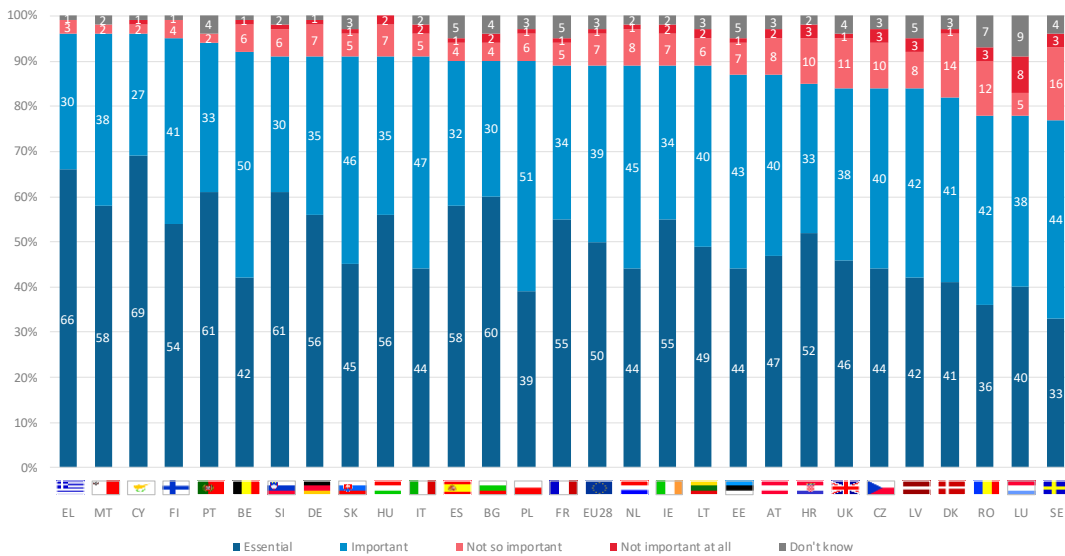

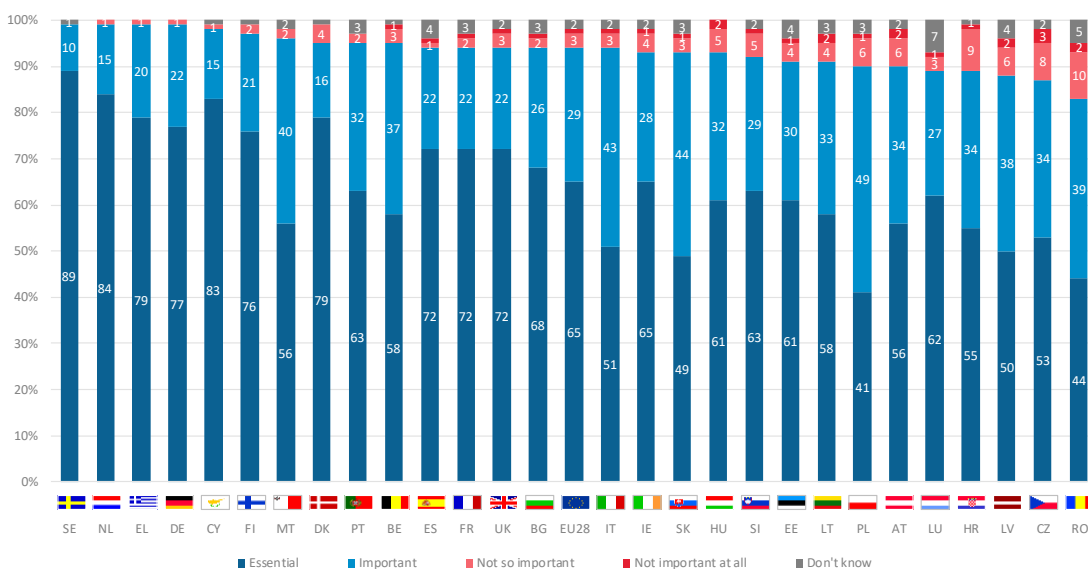
Q5.2 How important for you personally are the following points?

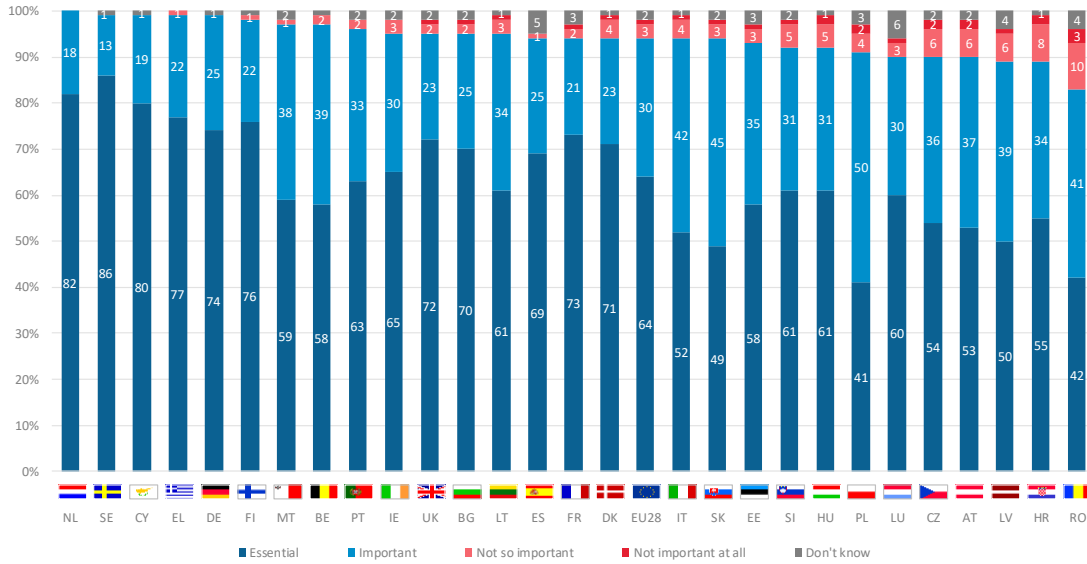

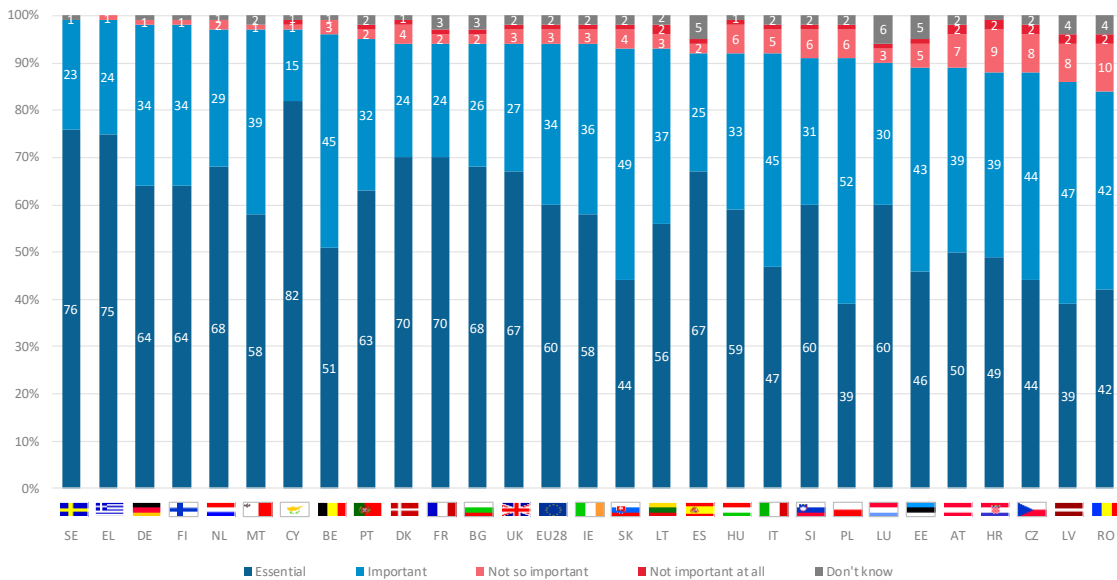

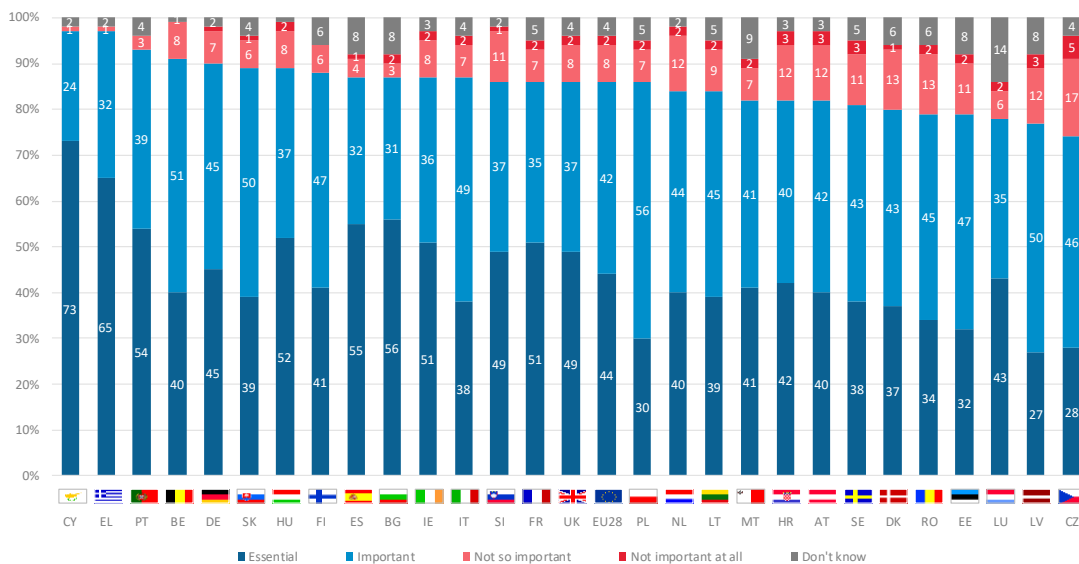

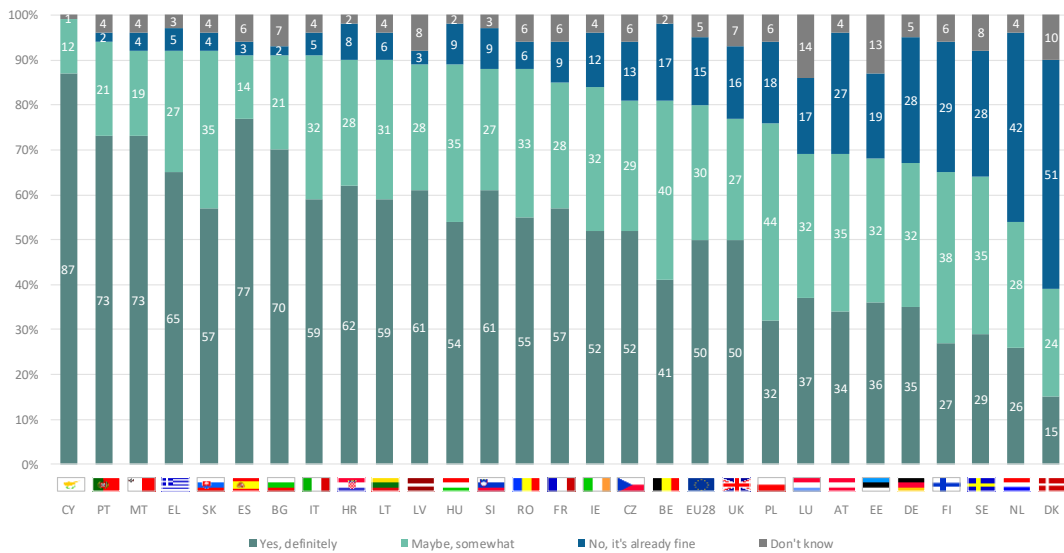
Perceived need of improvement of the situation: national results

There is a broader range in the proportions who think the situation in their country regarding these principles need to be improved, compared to the range for perceived importance. However, for each principle, the majority in each country think there needs to be improvement (those who answer “yes, definitely” and “maybe, somewhat”). In a number of countries, a considerable proportion consider each principle to be already fine in their country.

The socio-demographic analysis shows only small differences within groups in the proportions who think each principle needs improvement.

The situation in relation to **access to an independent court for rights is seen as needing improvement to some extent by 80% of all EU28 respondents**. The proportion who think it definitely or somewhat needs improvement ranges from 39% in Denmark, 54% in the Netherlands and 64% in Sweden to 92% in Malta, 94% in Portugal and 99% in Cyprus. In 18 countries, a majority thinks that the situation regarding this principle definitely needs improvement.

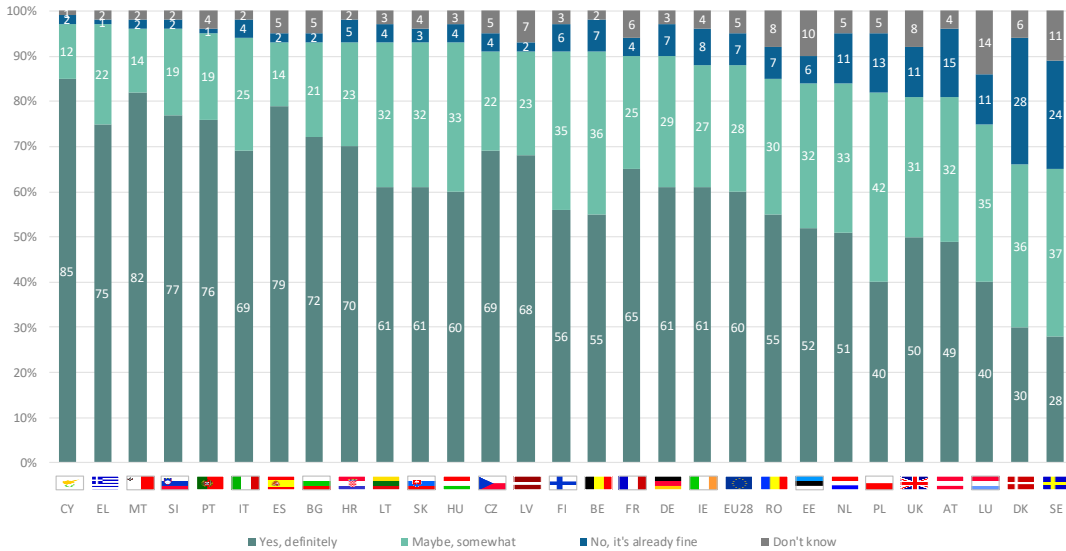

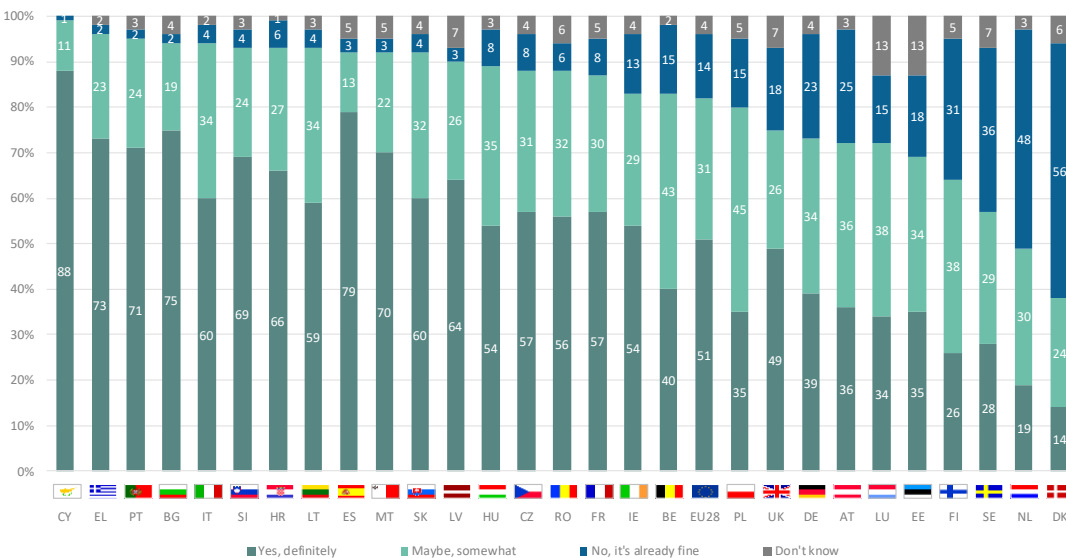

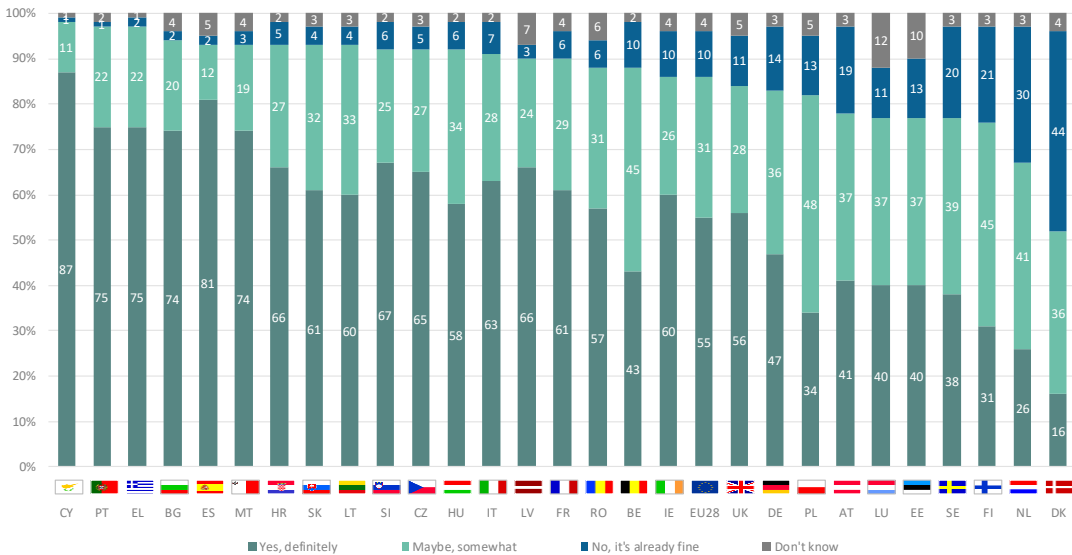

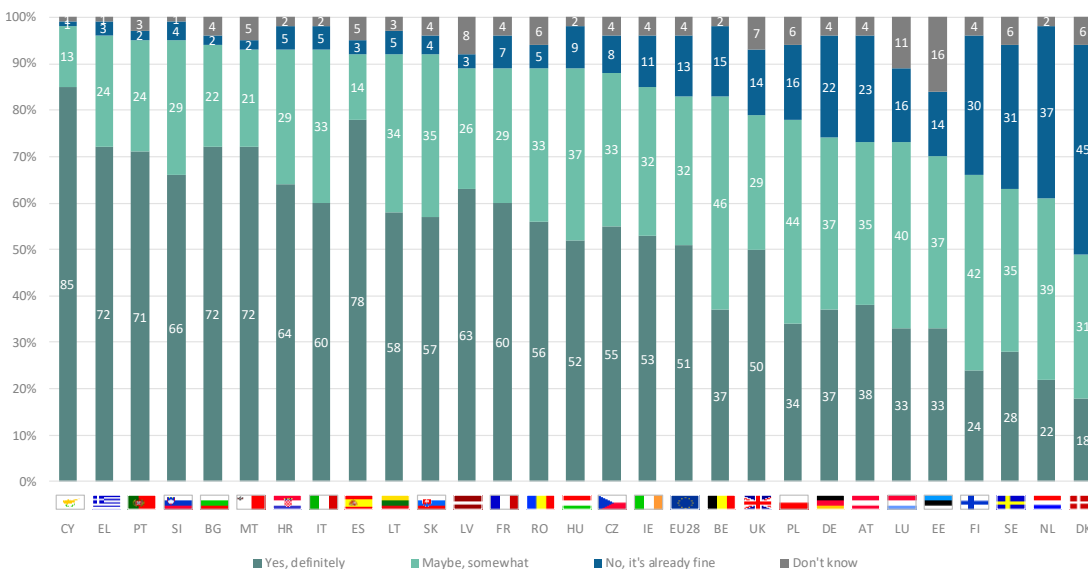

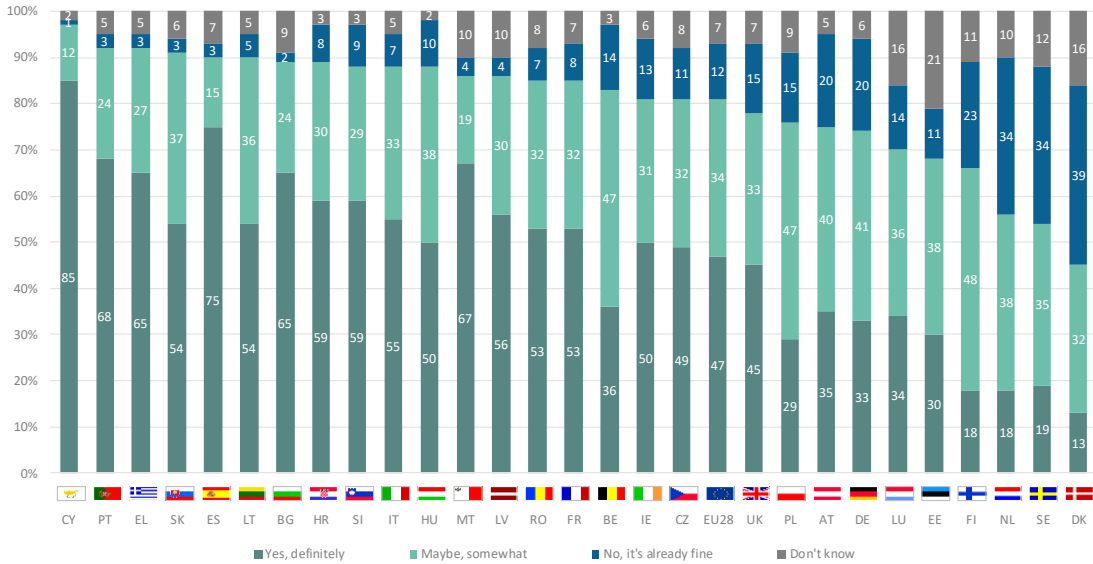

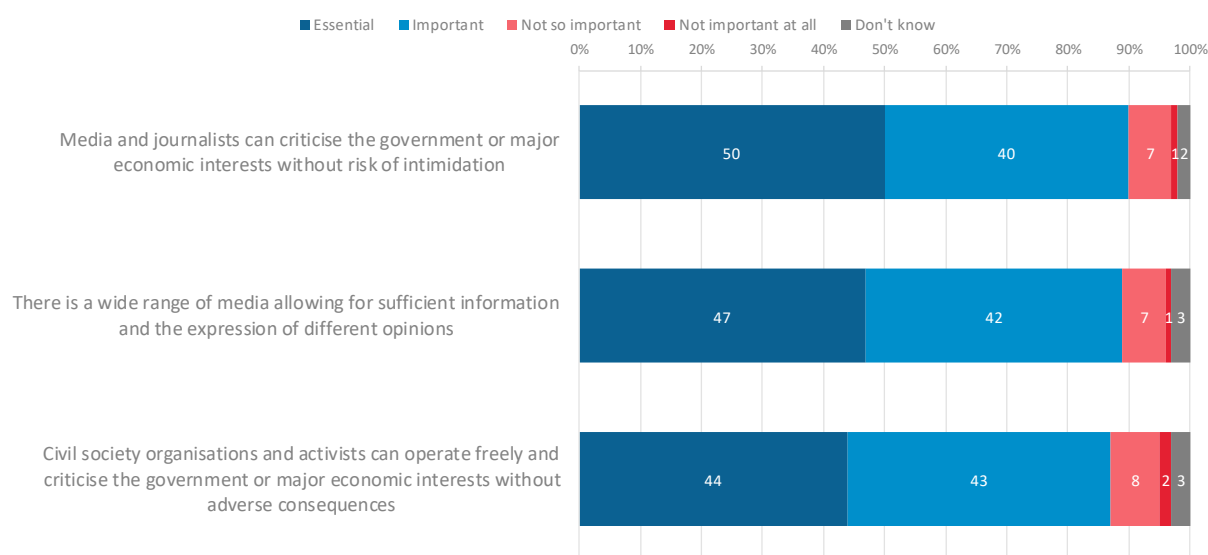
IV. MEDIA AND CIVIL SOCIETY

This section of the report explores the perceived importance and need for improvement in three aspects concerning the role of the media and civil society in promoting respect for the rule of law.

Each of the three aspects relating to the role of media and civil society in the rule of law is important or essential to at least 87% of respondents

For each of these three aspects, more than eight in ten respondents think they are important overall, and there is little variation¹⁵. The fact that no more than 2% say each aspect is not important at all further highlights the consensus of opinion.

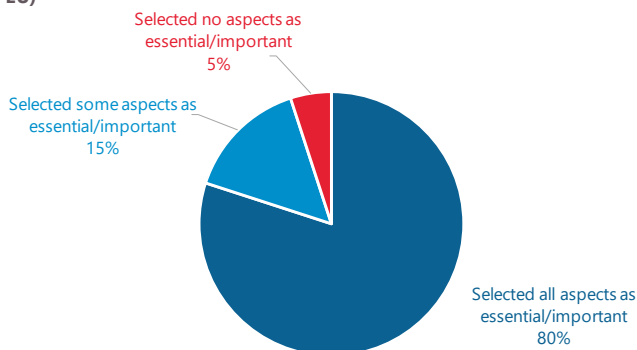
Q7 How important for you personally are the following points? (% EU)

Index 7R Share of respondents who selected a given number of aspects as essential and important Media and civil society (% - EU)



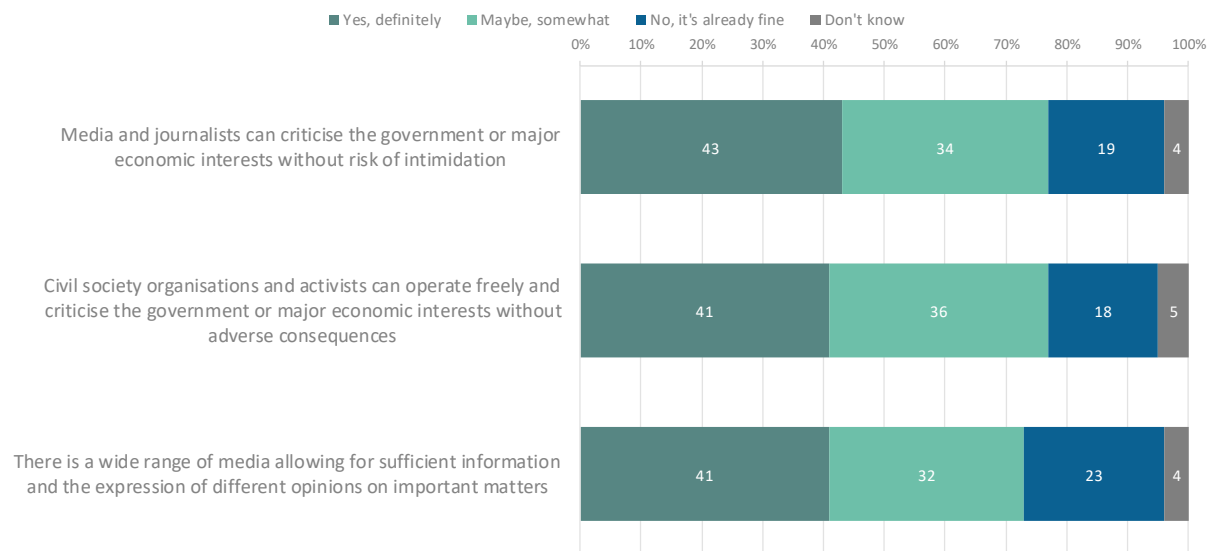

Between 73% and 77% of respondents consider the situation in their country in regard to aspects about the media and civil society need to be definitely or somewhat improved

The majority of respondents say each aspect needs improvement in their country (answer “yes, definitely” or “maybe, somewhat”), ranging from 73% for the plurality of the media to 77% for the non-intimidation of the media¹⁶.

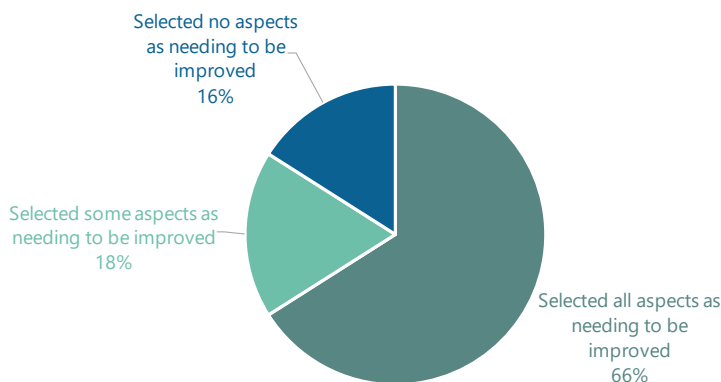
Q8 Please tell me whether the following points need to be improved in (OUR COUNTRY)? (% EU)

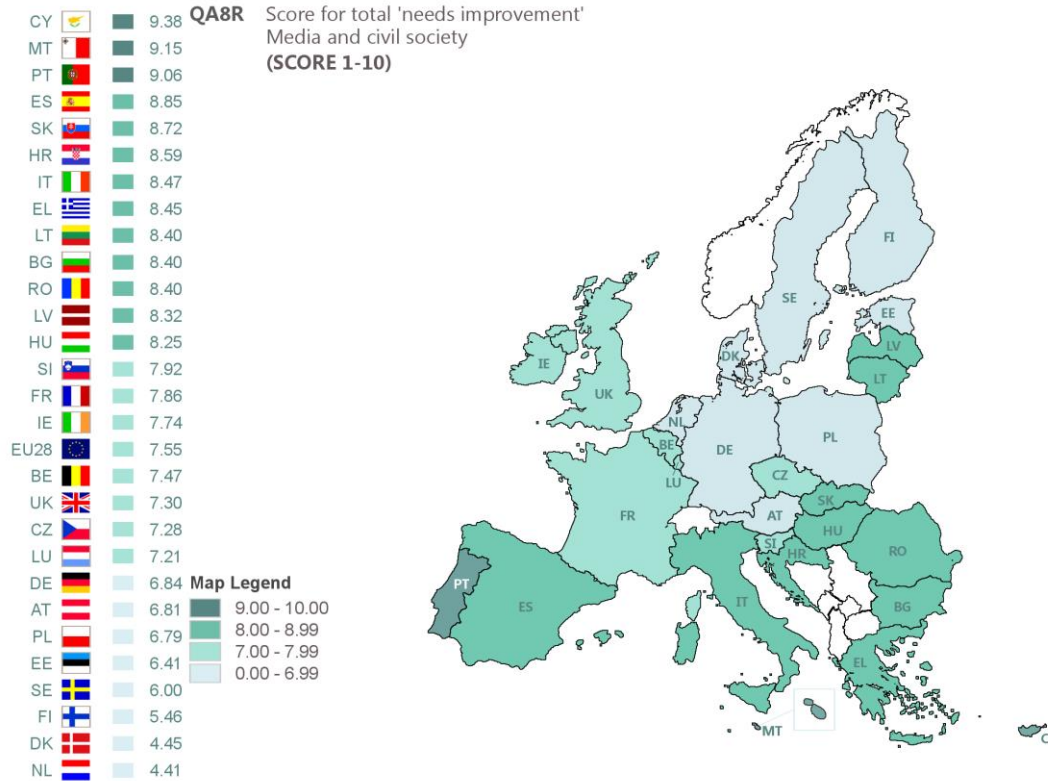
Index 8R Share of respondents who selected a given number of aspects as needing to be improved **Media and civil society** (% - EU)

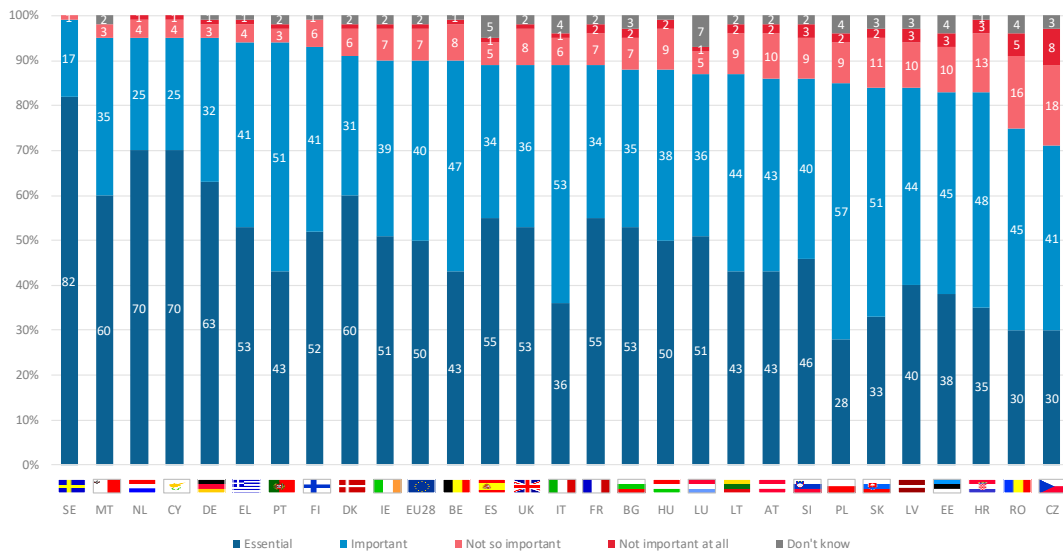

The proportion who think this principle is essential or important ranges from 71% in Czechia, 75% in Romania and 83% in Croatia and Estonia to 95% in Cyprus, Netherlands, Germany and Malta, and 99% in Sweden. In 16 countries, a majority thinks that this aspect is essential.

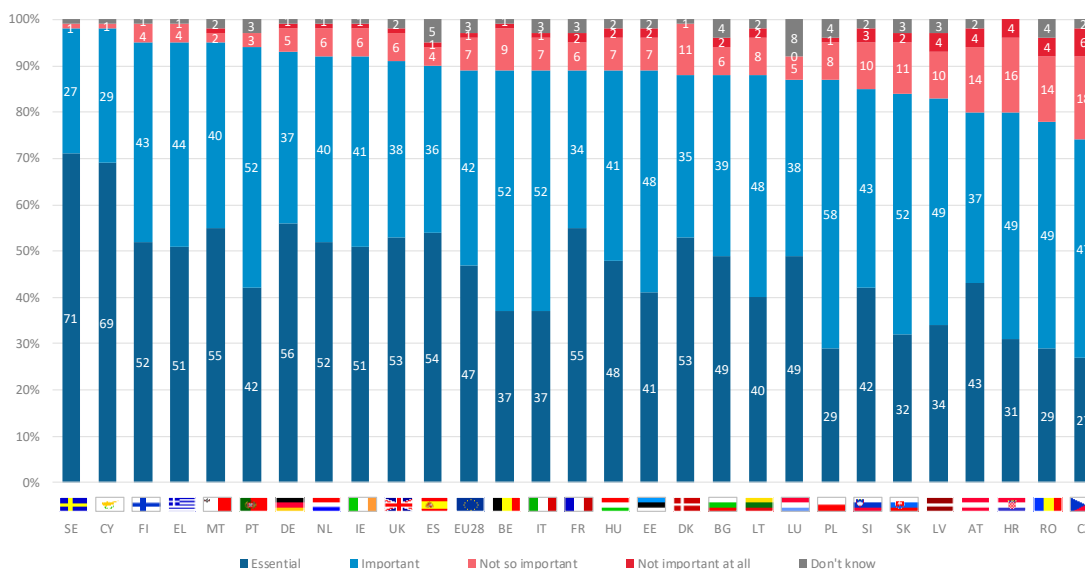
Q7.1 How important for you personally are the following points?

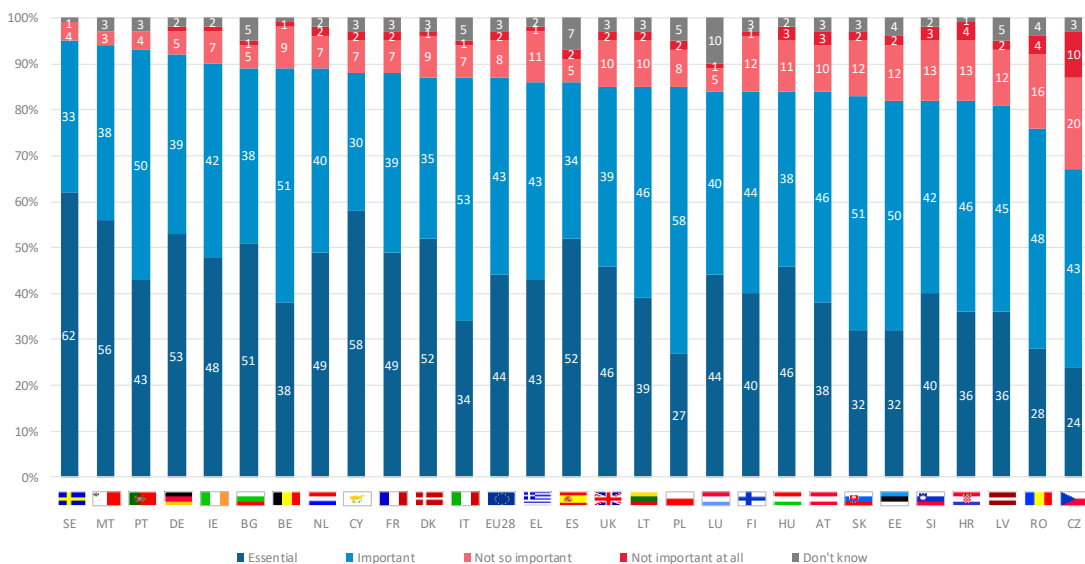
Q7.2 How important for you personally are the following points?

The non-intimidation of civil society organisations and activists is seen as important or essential by 87% of respondents in the EU. The proportion who think this principle is essential or important ranges from 67% in Czechia, 76% in Romania and 81% in Latvia to 93% in Portugal, 94% in Malta and 95% in Sweden. In 7 countries, more than a half believe that this aspect is essential.

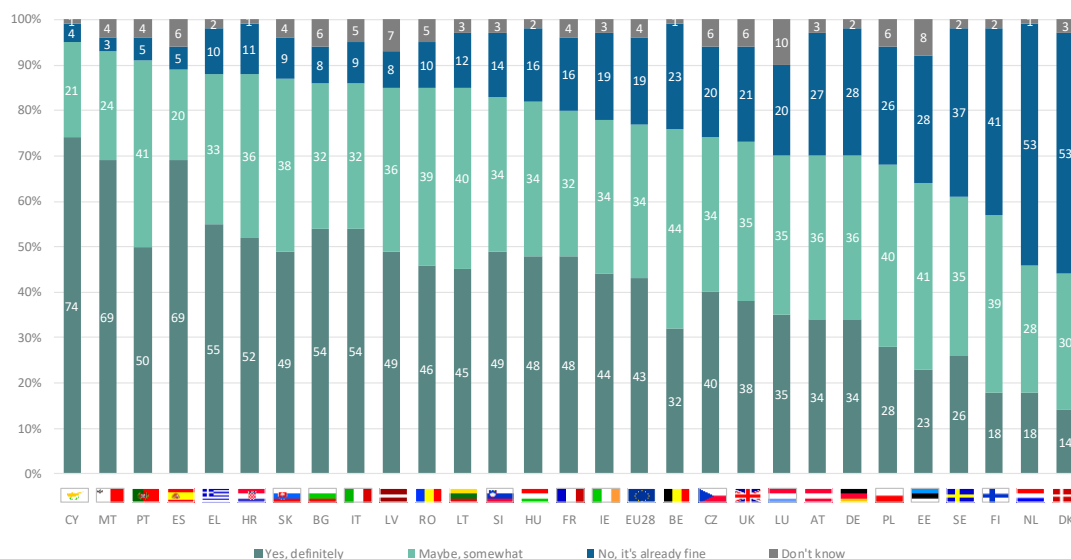
Perceived need for improvement of the situation: national results

There is a wide range in opinion across countries about whether these aspects need to be improved in their country, and in some countries only a minority think improvement is needed (those who answer “yes, definitely” and “maybe, somewhat”). In fact, in a number of Member States, a substantial share thinks these aspects are already fine in their country.

The socio-demographic analysis generally shows no notable differences within groups in the proportions who think each aspect needs improvement.

The situation of non-intimidation of the media is seen as needing improvement to some extent by 77% of respondents in the EU. The proportion who think definitely or somewhat that it needs improvement ranges from 44% in Denmark and 46% in the Netherlands to 91% in Portugal, 93% in Malta and 95% in Cyprus. In 8 countries, a half or more of respondents stated that the situation regarding this aspect should definitely be improved in their country.

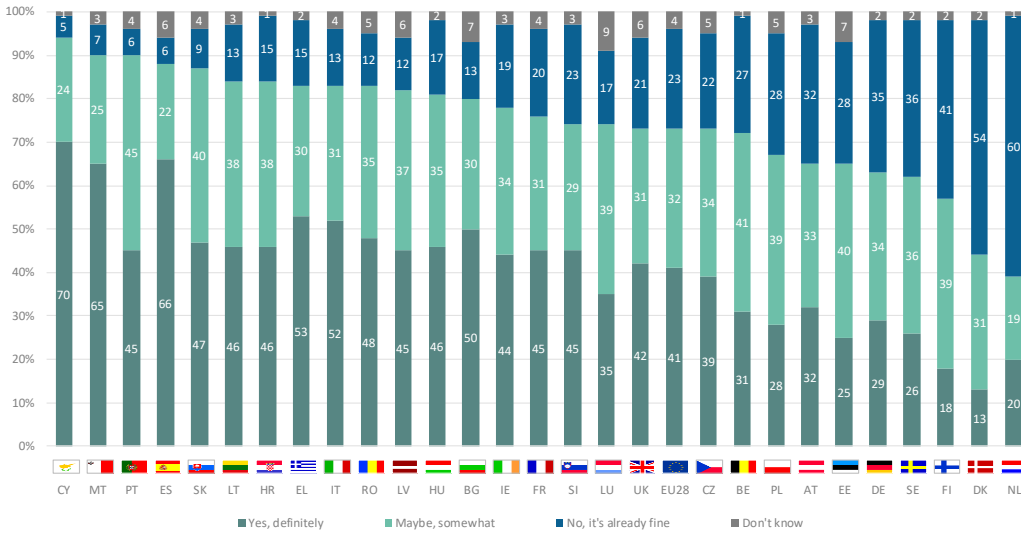
Q8.1 Please tell me whether the following points need to be improved in (OUR COUNTRY)?

The situation regarding **media pluralism is seen as needing improvement to some extent by 73% of all the EU28 respondents**. The proportion who think definitely or somewhat that it needs improvement ranges from 39% in the Netherlands, 44% in Denmark and 57% in Finland to 90% in Malta and Portugal, and 94% in Cyprus. In 6 countries, a half or more of respondents mentioned that the situation regarding this aspect definitely needs to be improved.

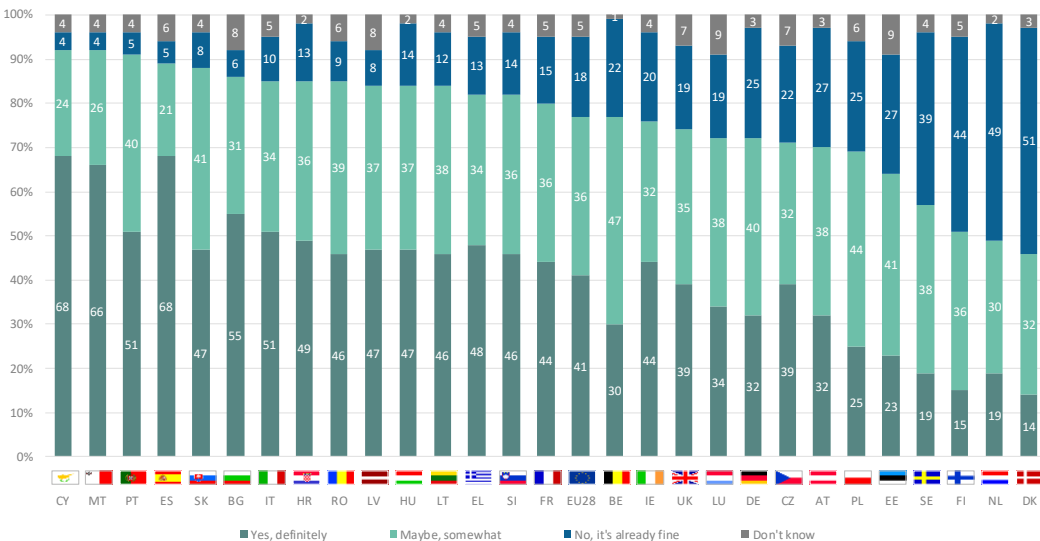
Q8.2 Please tell me whether the following points need to be improved in (OUR COUNTRY)?

The situation regarding the non-intimidation of civil society organisations and activists is seen as needing improvement to some extent by 77% of respondents in EU28 countries. The proportion who think definitely or somewhat that it needs improvement ranges from 46% in Denmark, 49% in the Netherlands and 51% in Finland to 91% in Portugal, and 92% in Cyprus and Malta. In 6 countries, more than a half of respondents believe that the situation pertaining to this aspect definitely needs improvement.

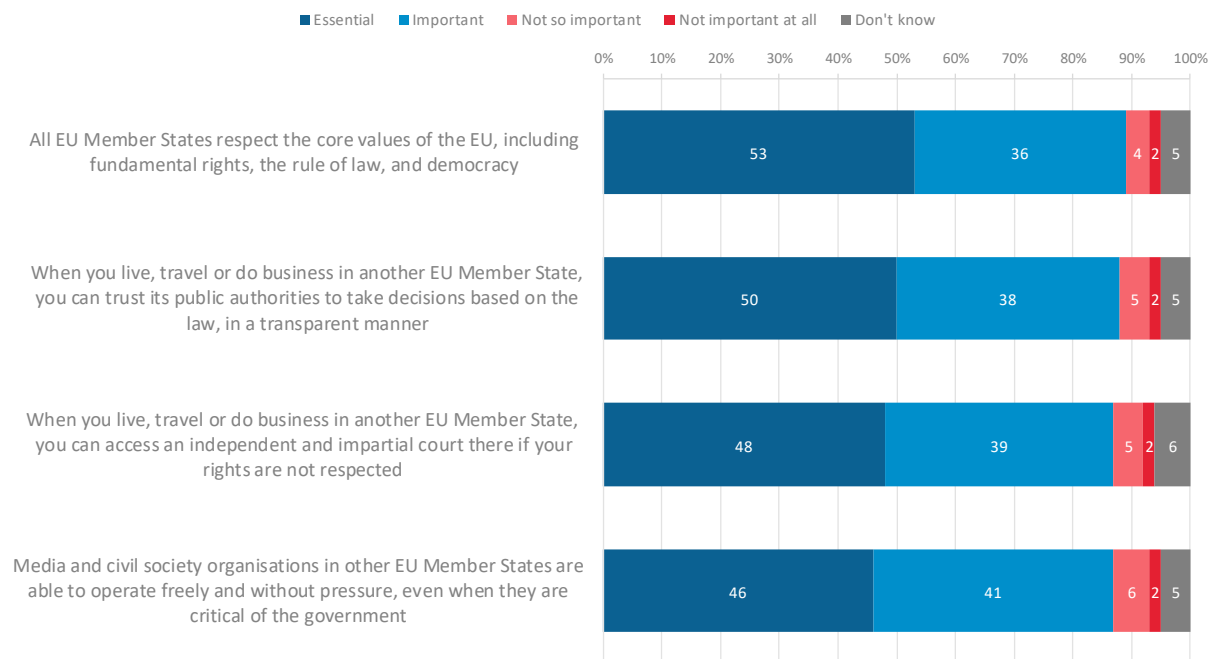
V. RULE OF LAW IN THE EUROPEAN UNION

This section explores opinions about the importance of the respect for the rule of law in the European Union and other Member States. The aspects covered concern respect for the core values of the EU, whether all EU Member States respect the core values of the EU, including fundamental rights, the rule of law, and democracy; trust in public authorities in other Member States; access to independent courts in other Member States; perceptions of freedom of media and civil society in the EU.

For each of the four questions on the rule of law in the EU and other Member States, at least 87% think it is important or essential

For each of these questions on rule of law, there is almost no variation in the proportion of respondents who think each is either essential or important¹⁷. The variation of perceived importance among principles is minimal. For each principle, just 2% think it is not important at all.

(% EU)

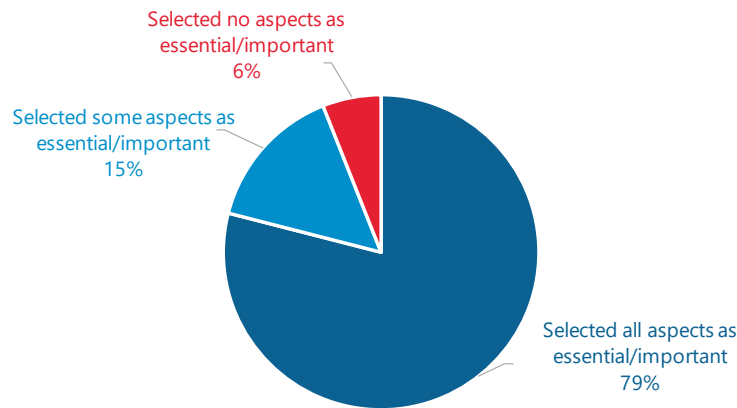

With regard to rule of law in the European Union and other Member States, 79% of respondents in the EU28 Member States have noted that all four questions on the rule of law in the EU and other Member States are essential or important, while an additional 15% have mentioned this regarding some of these questions. Only 6% believe that none of these are essential or important.

 (% - EU)



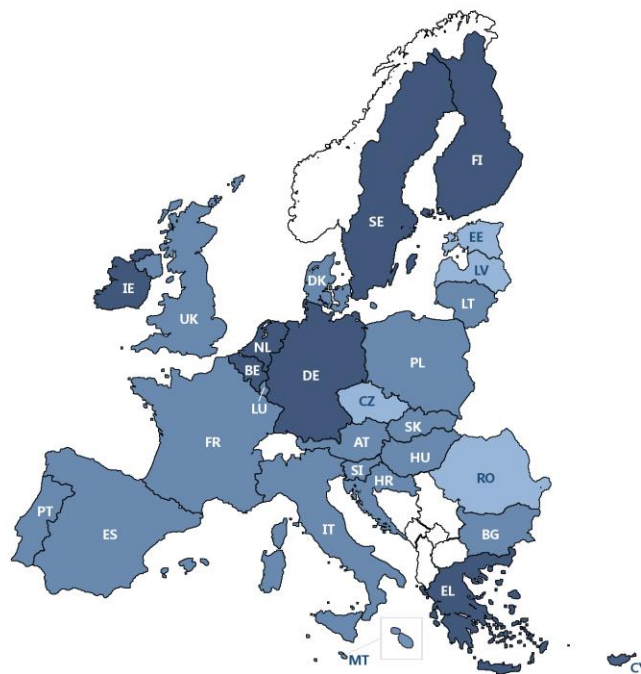

A large majority of respondents believes that all the aspects on the rule of law in the EU and other Member States are important

The score for the perceived importance for rule of law in the EU is 8.76 out of 10. The importance score ranges from 7.49 in Czechia, 7.59 in Latvia, 7.77 in Romania and 7.79 in Estonia to 9.38 in Germany, 9.43 in the Netherlands and Sweden, and 9.51 in Cyprus.

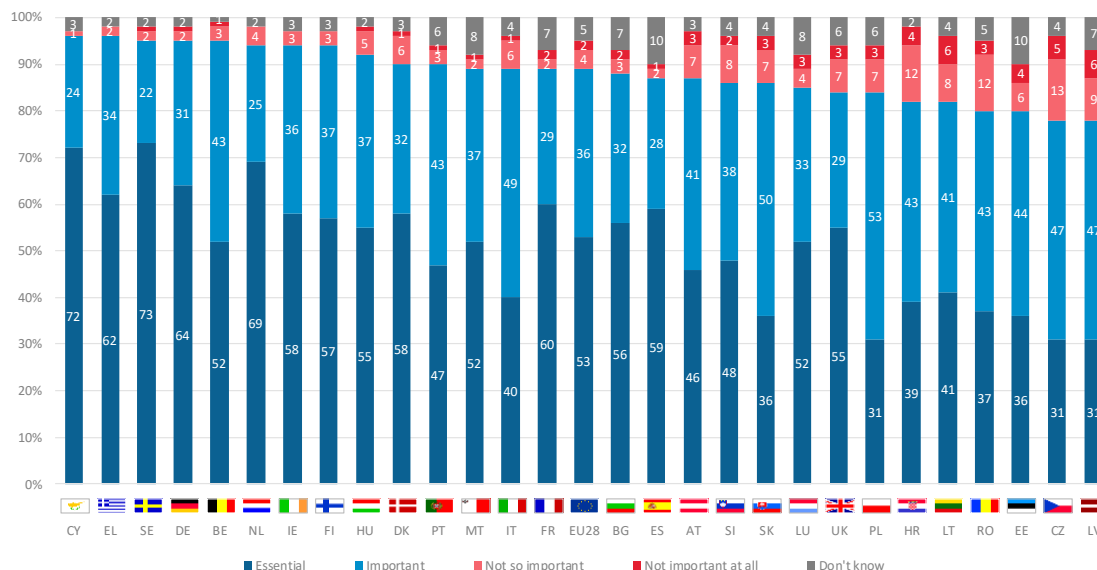
Perceived importance of the aspects: national results

The national-level results show more than two thirds of respondents in each country think each of these aspects is essential or important.

The socio-demographic analysis generally shows little difference between groups for this set of principles of rule of law.

Respect for the core values of the EU is seen as essential or important by 89% of respondents in the EU28. The proportion who think this aspect is essential or important ranges from 78% in Latvia and Czechia and 80% in Estonia and Romania to 95% in Sweden, Germany and Belgium, and 96% in Cyprus and Greece. In 16 countries, a majority believes that this aspect is essential.

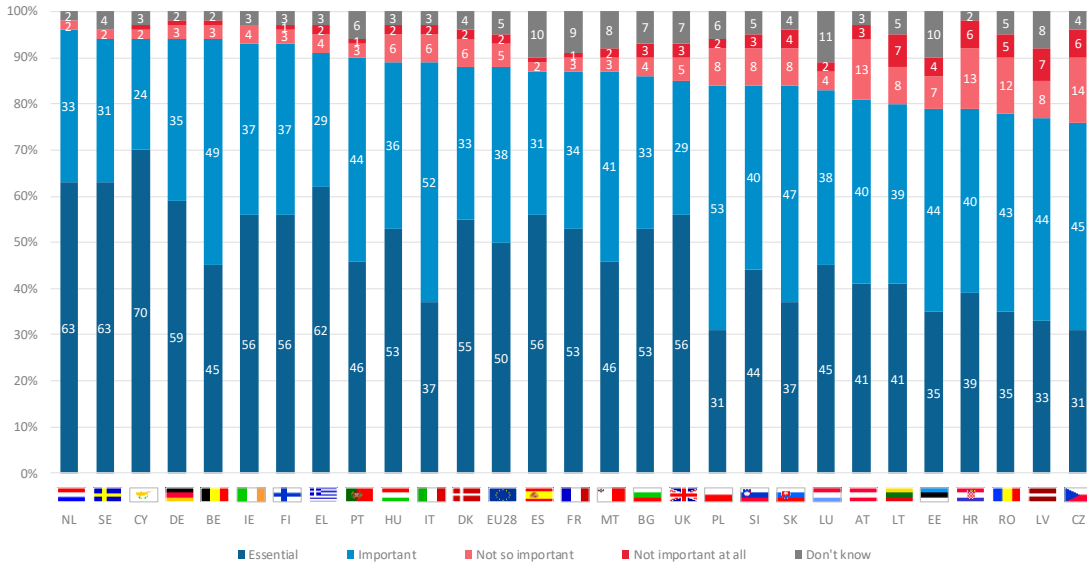
Q9.1 How important for you personally are the following points?

Trust in public authorities in other Member States is seen as important or essential by 88% of all EU28 respondents. The proportion who think it is essential or important ranges from 76% in Czechia, 77% in Latvia and 78% in Romania to 94% in Belgium, Germany, Cyprus and Sweden, and 96% of respondents in the Netherlands. In 13 countries, a half of respondents or more hold the belief that this aspect is essential.

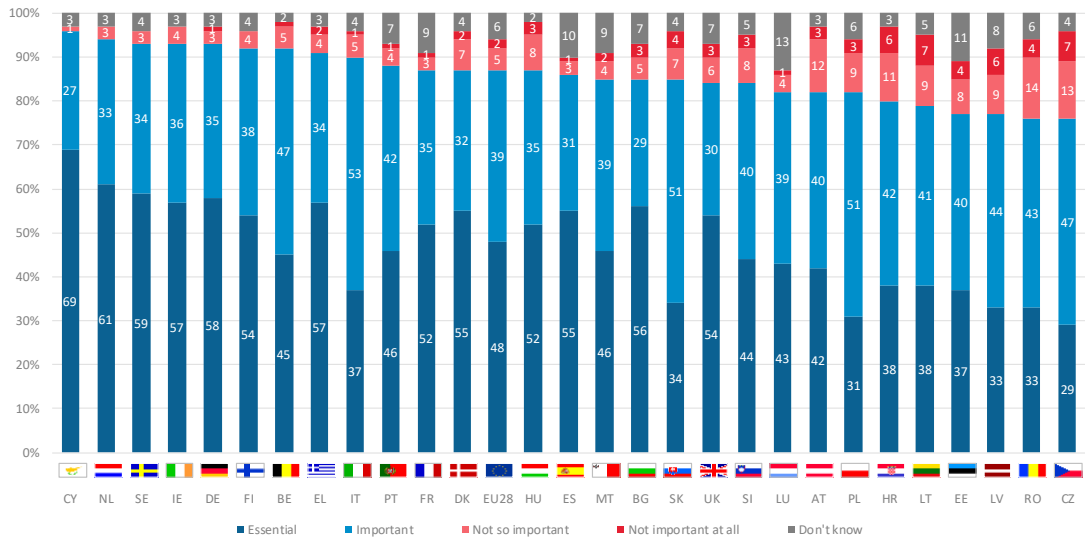
Q9.2 How important for you personally are the following points?

Access to independent and impartial courts in other Member States is seen as important or essential overall by 87% of all EU28 respondents. The proportion who think this is essential or important ranges from 76% in Romania and Czechia and 77% in Latvia and Estonia to 93% in Germany, Ireland and Sweden, 94% in the Netherlands, and 96% in Cyprus. In 12 countries, majorities think that this aspect is essential.

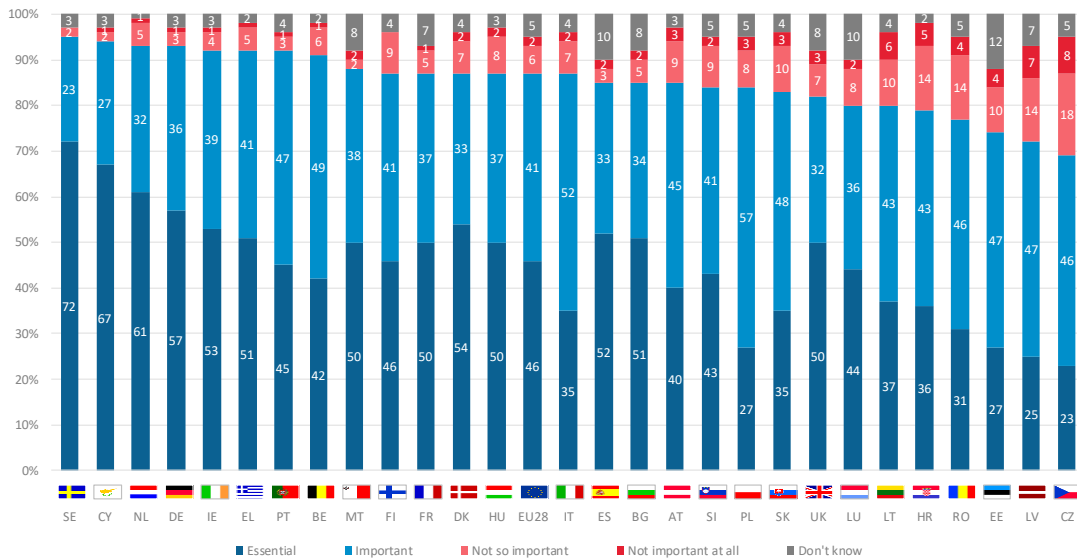
Q9.3 How important for you personally are the following points?

The aspect that media and civil society can operate freely in other Member States is seen as important or essential by 87% of EU28 respondents. The proportion who think this is essential or important ranges from 69% in Czechia, 72% in Latvia and 74% in Estonia to 93% in the Netherlands and Germany, 94% in Cyprus, and 95% in Sweden. In 12 countries, a half or more of the respondents believe that this aspect is essential.

Media and civil society organisations in other EU Member States are able to operate freely and without pressure, even when they are critical of the government (% EU)



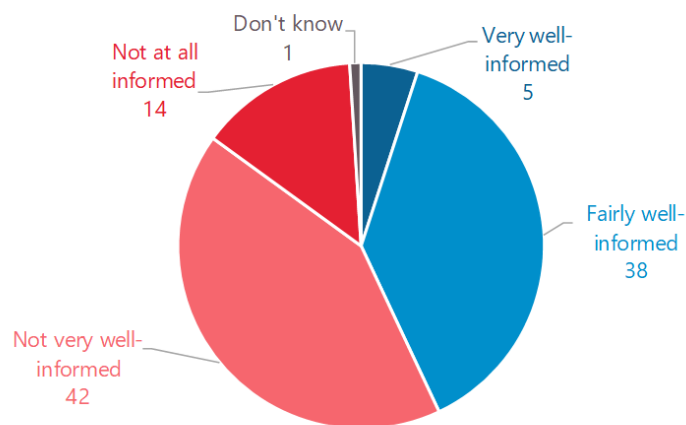

VI. PERCEIVED LEVEL OF INFORMATION ABOUT THE EU'S FUNDAMENTAL VALUES

A majority does not feel informed about the EU's fundamental values

Almost six in ten respondents (56%) say they do not feel informed about the EU's fundamental values: 42% say they feel "not very well informed", while 14% say they are "not at all informed". On the positive side, more than four in ten (43%) say they feel well informed about the EU's fundamental values, with 5% feeling "very well informed" and 38% feeling "fairly well informed"¹⁸.

(% - EU)



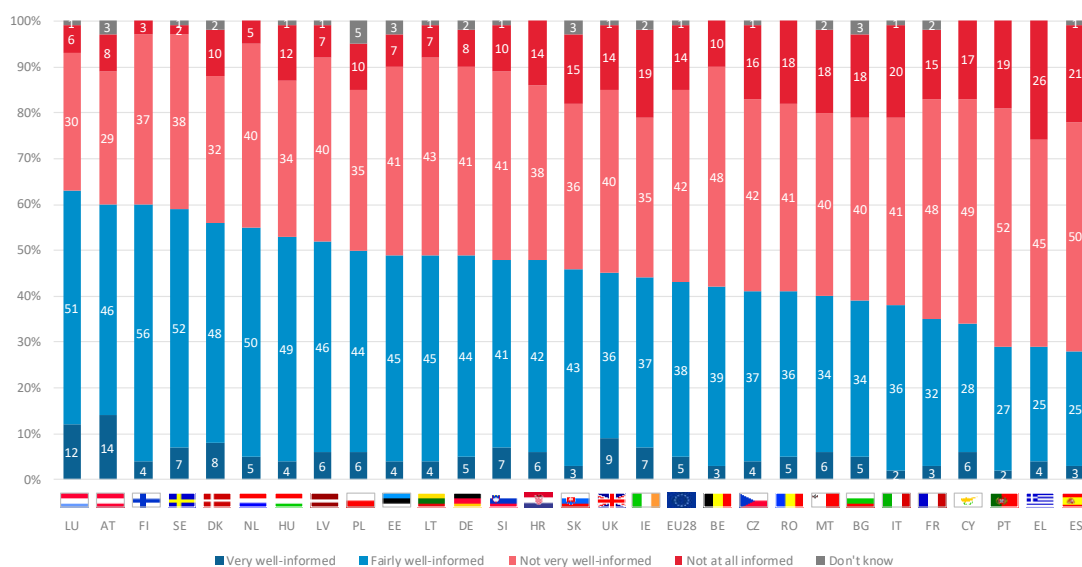

In most countries, the majority of respondents state that they are not very well informed or not at all informed about the EU’s fundamental values. In 18 countries, at least 50% of respondents selected one of these options. There are 19 countries where at least one in ten respondents say they are “not at all informed” about the EU’s fundamental values, with the highest shares recorded in Greece (26%), Spain (21%) and Italy (20%).

The proportion of respondents who say they are “not very well informed” ranges from 29% in Austria, 30% in Luxembourg and 32% in Denmark to 49% in Cyprus, 50% in Spain and 52% in Portugal.

CONCLUSIONS

The results of this Eurobarometer survey clearly show the widespread perception that the principles of rule of law are important for EU citizens. They also illustrate a remarkable consistency of opinion across the 17 core principles covered. For each principle, more than eight in ten say it is important for them, and in many cases more than nine in ten say this. This consensus is further reinforced by the fact that no more than two in one hundred think any given principle is not important at all.

There is also a consistency of opinion in each of the five thematic areas into which the principles were grouped, with relatively little variation in importance between the principles within each group. Although the importance of each group of principles is high, extra importance is placed on those principles relating to the prohibition of arbitrariness, penalties for corruption and effective judicial protection by independent courts.

Not only do large majorities think each of these principles is important, but all are considered to need at least some improvement in the countries of respondents. For each principle, more than 70% think improvement is needed, and in some cases at least nine in ten think this way. In most cases, no more than around one in ten thinks a given principle is already fine as it is, further illustrating the relative conformity of opinion across the EU. As in the case of importance, across the thematic areas there is little variation between individual principles in the proportion of respondents who say improvement is needed.

This consistency of opinion also holds at a national level in matters of importance, where there is very little variation. In fact, the overall importance scores for each thematic area, at country level, range from 7.1 to 9.8 out of 10. The importance scores are most narrowly distributed at country level regarding the prohibition of arbitrariness and penalties for corruption heading (country scores range from 8.0 to 9.1). On matters of importance, none of the individual Member State results deviate markedly from the EU average.

The situation, when it comes to the perceived need for improvement, presents larger variations at a national level.

In addition, the survey showed that consistently more than two thirds of respondents believe that aspects related to the rule of law in other Member States and in the EU as a whole are essential or important for respondents. In each of the countries, at least 89% of respondents acknowledged that respect for principles of rule of law as well as fundamental EU principles are important or essential.

Respondents in EU28 countries perceive that trust in public authorities in other Member States is important, with 88% stating that this aspect is essential or important to them. Similar shares of respondents further supported the importance of access to independent and impartial courts in other EU countries and the ability of media and civil society to operate freely in other Member States.

The study also showed that respondents tend to feel rather uninformed about EU's fundamental values – 56% claimed that they are not very well or not at all informed about these aspects, and only a minority of 5% stated that they are very well informed in this regard.

In conclusion, the results point towards overwhelming agreement among EU citizens about the importance of principles of rule of law and the need to further support this pursuit.

METHODOLOGICAL NOTE

Two sets of scores were computed for the principles of Rule of law: the importance score and the need for improvement score.

The score across principles is calculated by assigning a score from 1 to 10 to each of the principles based on the share of respondents who stated a given principle is essential or important for them personally. The scores across the principles are subsequently averaged. The share of respondents who consider a given principle as important is divided by 10 resulting in a score between 1 and 10.

This means that the scores reflect the level of perceived importance and the need for improvement across the 17 main principles. Given that it is not possible to compute an average of percentages, the score cannot be understood as the share of respondents who consider rule of law principles as important.

The basic sample design applied in all states is a multi-stage, random (probability) one. In each country, a number of sampling points was drawn with probability proportional to population size (for a total coverage of the country) and to population density.

In order to do so, the sampling points were drawn systematically from each of the "administrative regional units", after stratification by individual unit and type of area. They thus represent the whole territory of the countries surveyed according to the EUROSTAT NUTS II (or equivalent) and according to the distribution of the resident population of the respective nationalities in terms of metropolitan, urban and rural areas.

In each of the selected sampling points, a starting address was drawn, at random. Further addresses (every Nth address) were selected by standard "random route" procedures, from the initial address. In each household, the respondent was drawn, at random (following the "closest birthday rule"). All interviews were conducted face-to-face in people's homes and in the appropriate national language. As far as the data capture is concerned, CAPI (*Computer Assisted Personal Interview*) was used in those countries where this technique was available.

For each country a comparison between the sample and the universe was carried out. The Universe description was derived from Eurostat population data or from national statistics offices. For all countries surveyed, a national weighting procedure, using marginal and intercellular weighting, was carried out based on this Universe description. In all countries, gender, age, region and size of locality were introduced in the iteration procedure. For international weighting (i.e. EU averages), Kantar Public applies the official population figures as provided by EUROSTAT or national statistic offices. The total population figures for input in this post-weighting procedure are listed here.

Readers are reminded that survey results are estimations, the accuracy of which, everything being equal, rests upon the sample size and upon the observed percentage. With samples of about 1,000 interviews, the real percentages vary within the following confidence limits:
